

HEMP INDUSTRY ACT 2008

Delegation by Director-General

I, RICHARD FREDERICK SHELDRAKE, Director-General of the Department of Industry and Investment, pursuant to section 41 of the Hemp Industry Act 2008 (“the Act”):

1. revoke the instrument of delegation published in *NSW Government Gazette* No. 141 of 7 November 2008 at pages 10730 to 10731 and any instrument revived as a result of this revocation;
2. delegate the functions conferred or imposed on me by the section of the Act specified in Column 1 of Schedule 1 to the member of staff of the Department of Industry and Investment who from time to time holds, occupies or performs the duties of the position described opposite in Column 2 of Schedule 1; and
3. delegate the functions conferred or imposed on me by the clause of the Hemp Industry Regulation 2008 specified in Column 1 of Schedule 2 to the member of staff of the Department of Industry and Investment who from time to time holds, occupies or performs the duties of the position described opposite in Column 2 of Schedule 2.
