- I must comply with the Apiaries Act 1985 and other legislation, including: promptly notifying any signs of notifiable bee diseases or pests to an inspector; ensuring that my registration number is clearly displayed on the broodbox of every hive; maintaining a record of the movement of my beehives and providing these records to an inspector on request; notifying the sale or disposal of any beehives within 21 days. I should examine my hives regularly for signs of any notifiable bee disease or pest. I should manage my hives to minimise the risk of a nuisance or threat to the amenity or health of any other person or property.

APPLICATION FOR REGISTRATION AS A BEEKEEPER (continued)

Registration is valid for two years and must be renewed before the expiry date.

There are 3 classes of beekeeper registration:

Business: carry on the business of beekeeping, have an ABN and are registered for GST

Recreational: keep bees primarily for recreational purposes

Concession: recreational beekeeper holding a valid Pensioner Concession Card or Seniors Card
