#### **Logbooks**

All quota logbooks and catch records of the transferor/transferee, including any nil returns, must be up-to-date upon submission of the application. Abalone and lobster shareholders are required to submit a copy of their current monthly reconciliation form completed to the current date, signed and dated. Quota will be reconciled for the transferor/transferee prior to the transfer being completed. If logbook information is not up-to-date, your application will be refused.
