New boat licences will only be issued for operation in the sea urchin and turban shell or inland restricted fisheries, or the abalone or lobster share management fisheries. If the applicant is not the owner, authorised fisher, or an eligible fisher for a fishing business with an endorsement or shares in these fisheries, a licence will not be issued. A condition will be included on the licence, if issued, restricting the licence to use in the fishery specified.

## Boat details verification

In accordance with Clause 145 of the Fisheries Management (General) Regulation 2010, prior to submission of this application, the dimensions of the physical boat to be attached to the licence are required to be verified either through inspection by the District Fisheries Officer, by providing a current NSW Maritime Authority survey certificate or certification by a marine surveyor.
