Revised arrangements for catch effort reporting

Peter Brown, Manager Systems Reform, NSW DPI gave a presentation regarding the catch records reform project, providing an update of project progress so far. He advised that the project was on schedule to implement new catch and effort reporting arrangements across all fisheries in July, 2009. He further advised that a document describing the new arrangements that incorporates changes arising from the consultation process will be released before Christmas 2008 and that DPI plans to run a pilot program in February, 2009 to test the new arrangements in the field.

Agenda item 12**Indictable offences – update by DPI**

There are 6 FTE (full time equivalent) compliance officers working on abalone currently. If, as the abalone MAC requests, more resources are directed to abalone issues, then less resources would be available for other fisheries. In addition, DPI works constructively with a number of other agencies, which provides a greater deterrent to fisheries crime.

Agenda item 14**Use of Electronic Data Entry**

Jim Miller advised SIAC that the Abalone MAC raised concerns about the OH&S risk of forcing deckhands to record catch data at a 300m scale while the diver is in the water. The MAC recommends that because most divers have data loggers which will record data at a finer scale, that the proposed paper based system is unnecessary.

DPI advised that deckhands will not be forced to undertake unsafe reporting practices. When industry has the new electronic system set up, and the information gained is provided to the department, industry will not be required to complete a second spatial information collection. The current paper based system supports, and is an integral part of, the quota based system, and DPI will work with the MAC on this.

Mr Miller moved that the following resolution be adopted.

The Abalone MAC does not support the finer scale reporting changes proposed by the Catch Records Project and that the priority for Departmental funds should be to be able to enter the data electronically, as in most other states, because of the cost recovery environment.

The resolution lapsed through want of a seconder.

Other Business

- A copy was tabled of a speech by Professor Bob Kearney on Science and Marine Parks in NSW.
- SIAC agreed that, subject to meeting privacy legislation requirements, the Executive Officer is to distribute on a confidential basis the personal details of all SIAC members to Council members who request those details.
- A request was made to discuss protocols for the consultation process at the next meeting.
- The Chairman reiterated the need for members to avoid any conflict of interest, and to maintain confidential the information discussed at meetings.
- Members discussed the recent Regulation changes which were enacted following legal advice that the section 8 closures needed to be included in legislation following the Share Management process.
- Members were advised of Stakeholder Consultation meetings on Pilot Offshore Artificial Reefs on 25.11.08 in Newcastle, 27.11.08 in Sydney and 8.12.08 in Wollongong. This information was also circulated to all the MACs.
- Doug Hocking announced that George Davey will become the new Deputy Director-General and Executive Director Fisheries Compliance and Regional Relations in NSW DPI, effective immediately. He also advised members that he will be retiring in February.
- The Chairperson requested that a vote of thanks to Doug Hocking be recorded in the minutes for his contribution.
