Share Management Plan implementation update

Background

The Estuary General Fishery and Ocean Hauling Fishery Share Management plans commenced on 5 February 2007. Additionally, a number of amendments were made to the *Fisheries Management (General) Regulation 2002* to provide for more flexible licensing arrangements.

All MAC representatives have been supplied with a copy of the current version of the Act, Regulations, Supporting Plan and relevant fishery management plans.

An overview of share trading arrangements will be provided for the Committee's information.

The Department has created a general information line (1300 720 662) for stakeholders with queries relating to the new arrangements. Since the creation of the phone line in February 2007, the Department has received and registered a significant number of phone calls from stakeholders.

The majority of the phone calls received relate to:

- share trading rules and minimum share holdings
- nomination arrangements
- applications for commercial fishing licences
- the transferability of commercial boat licences
- specific rules relating to each plan
- queries relating to a fishing business determination certificates
- require assistance through the share trading application form

Most callers have been supportive of the new share management and licensing arrangements.

Issue

Proposed regulation amendments.

Background

Various amendments to current operating requirements have previously been discussed with the MACs in relation to the requirements of the Fisheries Management Strategies. Whilst some of the required changes were implemented within the current share management plans other less critical changes were deferred until the share management plans were implemented.

Previously discussed changes to gear descriptions and operational requirements as well as fishery specific closures will progressively be moved across in to the relevant share management plans.

A summary of the proposed change relating to the general purpose hauling net is outlined below.

Clause 26 – Hauling net (general purpose)

NSW DPI research has demonstrated that (i) the mesh size in the bunt of the general purpose hauling net is an important influence on what escapes or is retained and (ii) the current mesh size is inappropriate and if increased will improve the size selectivity of the gear with respect to under-sized fish that would otherwise be discarded. The Department proposes to increase the **maximum** mesh size of the centre piece of the bunt to 57mm and the remainder of bunt must consist of mesh **not less** than 57mm. The mesh size in the wings is to stay the same.

Background

a. Seagrass Mapping

To meet the objectives of the Estuary General and Ocean Hauling Fishery Management Strategies Clause 58B of the *Fisheries Management (General) Regulation 2002* was implemented to protect seagrass from hauling operations.

To assist in clarifying the location of seagrass beds and provide consistency in application it is proposed that the Regulation will be amended to prohibit hauling in areas outlined in gazetted maps.

Draft maps for Wallis Lake, Port Stephens and Pittwater have been produced in consultation with local stakeholders and the remaining significant areas will be mapped in the near future

b. Bivalve Harvest Area Classification

Previously, the Australia Shellfish Quality Assurance Program (ASQAP) was implemented by the States on a voluntary basis. However, a new section of the Food Standards Code, called the Primary Processing and Production Standard for Seafood was gazetted by Food Standards Australia New Zealand in May 2005. This standard adopted the ASQAP as the model standard and prescribed that all bi-valve shellfish for human consumption must be harvested from classified waters. A two year implementation period (until May 2007) was provided for in the standard.

Classification involves a sanitary survey of the harvest area based on a shoreline survey of potential pollution points and bacteriological sampling over a period of time to assess the on-going water quality trend in the harvest area. The sanitary survey is used to develop appropriate food safety controls for the risks identified.

Following initial classification the harvest area must be regularly monitored every year by manner of shoreline survey updates and a brief review report for each harvest area.

The Department has been liaising with the NSW Food Authority regarding the initial classification process and development of an ongoing monitoring programme. Further discussion with shareholders regarding maintenance of the programme will be undertaken once a proposal is developed.

c. Ocean hauling update.

There has been some progress on consultation over beach access for commercial fishers with the Department of Environment and Conservation (DEC). DEC has advised that a review of the procedural guidelines for the Professional Fishing Access Policy would commence in March 2007 and consultation with professional fishers and other key stakeholders will be undertaken.

A number of stakeholders have raised the issue of public liability insurance. As advised in the information package sent to shareholders and fishers, holding public liability insurance

is no longer a mandatory requirement of ocean beach haulers under fisheries legislation. Please note that other government agencies still require it as a condition of beach access.

Further a number of stakeholders have raised the issue of access to multiple regions. As advised in the information package sent to shareholders, fishers can now work each and every region in which they are endorsed.

NSW Maritime has informed the Department that compliance on the illegal use of petrol inboard engine use has begun and will continue this year.

Background The harvest of sea garfish in NSW estuaries has been closed since August 2003 whilst a recovery program was developed for this species. This closure is to remain in place until either the species is fully recovered or suitable alternative recovery actions are included in the management plan. In order to assist in an observer study, a limited number of section 37 permits were issued to fishers authorising the capture of sea garfish in specific waters of Port Stephens. Proposed Estuary General Regulation Amendments

Background

The Department will provide EGMAC members a summary of the proposals at the meeting, however a general overview is provided below.

Square-mesh codends

NSW DPI research has demonstrated that the size selectivities of most existing conventional prawn-catching gears used in NSW are inappropriate for the targeted prawns and that several unregulated factors, and especially hanging ratio and twine diameter, influence the selectivity of these gears, irrespective of mesh size. Codends made from mesh between 27 and 32mm hung on the bar (square mesh) will significantly improve the size and species selectivity of most Estuary General prawn seines and stow (set pocket) nets. Additionally, because the majority of prawns escaping through meshes appear to survive the process, the wide scale use of modified prawn-catching gears will reduce the fishing mortality of small prawns and other non target species.

The introduction of the requirement to use square-mesh codends in estuarine prawning operations is a major initiative requiring significant changes to the current regulation.

The Department proposes to amend the following clauses to require use square-mesh codends in place of conventional diamond-mesh codends. For some net types it may also be possible to provide the option to use larger diamond mesh.

- Clause 32 Prawn net (haul)
- Clause 33 Prawn net (haul) Manning
- Clause 34 Prawn net (haul) Wallis
- Clause 35 Prawn net (set pocket)*
- Clause 37 Seine net (prawn)

* This clause may give fishers the option to use larger diamond-shaped mesh (35 – 45mm) throughout the entire net or alternatively, the same larger diamond-shaped mesh to the body of the net and a square-mesh codend. No changes are proposed to the headrope lengths.

Amendments are also proposed to other clauses of the regulation such as the examples listed below and will be the subject of future industry consultation following initial discussion at this meeting.

- Clause 41 – Meshing net*
- Clause 43 – Flathead net*
- Clause 74 – Taking of Yabby, Worms, Pipis etc.*

Crab Trapping

Background

Mud crabs are a highly valuable commercial species and a highly sought after recreational species. The management of this species in NSW comprises gear restrictions, closures minimum size limits and bag limits to ensure sustainable harvest.

The wording of the current regulation limits an endorsement holder to setting a defined number of traps (10). The issue of equity has been raised with respect to persons who own multiple fishing businesses that contain mud crab trap shares. Under current regulation, if the owner of the business is also the endorsement holder, they are limited to 10 traps rather than being able to exercise their right with respect to the second business.

Region 2

Request for the EGMAC to discuss raising the minimum size of crab trap buoys from 100mm to 150mm to improve their visibility to trawl operators.

Agenda Item 4**Region 3****Issue**

Review of Closures

Background

Industry in Region 3 is concerned about limited access to the fishery since the creation of Marine Parks and Recreational Fishing Havens in NSW. More specifically it is maintained that, (i) the available waterways remaining open to commercial fishing are inadequate to ensure the industry's viability, and (ii) seafood consumers are missing out on a regular supply of lower priced fish due to the high cost associated with the harvest of the seafood. It is suggested that current section 8 closures be reviewed.

Departmental note

The Department is currently focusing on implement of share management and is moving specific closures into regulation (relevant fishery share management plans) with necessary minor modifications. Further consultation will occur with regard to drafting the appropriate regulations.

Ocean Hauling Fishery Code of Practice

Background

Following the introduction of the Ocean Hauling Share Management Plan compliance with the Ocean Hauling Code of Practice is no longer mandatory and some components of the code have now been incorporated into the Share Management Plan.

Industry now has the opportunity to provide suggestions and review the codes of practice for their fishery in light of the new operating requirements set out in the Share Management Plan.

Issue

Trading of purse seine shares independent of other Ocean Hauling Fishery share classes.

Background**Industry Position**

The Purse seine fishery is a boat-based fishery which is administered under different rules to the other Ocean Hauling sectors. Participation also requires specialised equipment, used in a manner that is very different to the rest of the OHF.

Generally there is little overlap between the species harvested by the purse seine sector and the hauling sector and the fishery operates in deeper waters, which represent approximately 99.9% of the prescribed area of the OHF.

The current linkage between purse seine shares and the rest of the OHF in share trading creates a significant impediment to efficient rationalisation of both the purse seine sector and the other OHF sectors.

The ability to trade purse seine shares independent of OHF shares would not generate any management issues in regard to spatial conflict, gear conflict and common species management, particularly since there are only a very small number of NSW purse seine operations authorised (<15) .

Departmental note

Share trading arrangements provide a mechanism whereby shares in a fishery may be transferred to another shareholder who does not already hold shares in that fishery, provided all the shares in that fishery are transferred to that shareholder. This ensures that the number of participants in each fishery does not increase. Future structural adjustment may provide an environment where more flexible trading arrangements may be considered.

Agenda Item 4 **Purse Seine**

Issue
Penning of fish after capture in the Ocean Hauling Fishery.

Background
Industry Position
The issue of temporary penning of fish has been discussed by the ocean hauling MAC a number of times over several years without resolution.

There are administrative and compliance issues for stakeholders retaining fish live after capture in both the beach hauling and purse seine sectors. The ability to pen fish would potentially assist with the following issues:

- Fish hauled at night by beach crews are sometimes held in the bag until daylight and appropriate transport vehicles are available.
- To maintain consistency of supply of fresh product to both human consumption markets and supply chain consistency of fresh product for value adding in vertically integrated processing operations in the purse seine sector.

The proposed inclusion of administrative mechanisms to enable this practice has not been addressed in the Share Management arrangements despite advice from NSW DPI that it was their intention to do so when the matter was last raised.

NSW DPI Position.
The SMPs are a foundation on which to build and a number of unresolved matters have been held over to ensure the Plans were made in a timely manner. Before determining if it appropriate to amend the current legislation to authorise penning practices, a detailed proposal to pen fish that met the approval of NSW Maritime and the appropriate planning authorities would be required. Any proposal for fish taken by the beach based sector would in addition need to address concerns about increase in effort, resource sharing and social factors.
