Fishing business owners are responsible for informing eligible fishers of any decision to cancel a registration of an eligible fisher or to revoke a nomination. Provided that the form is completed in the manner required, nominations and revocations take effect upon receipt of the application by NSW Department of Primary Industries (NSW DPI).

NOTE: A fisher is not taken to be an eligible fisher until registered by NSW DPI. By signing the application, the signatory confirms they hold a current class 1 commercial fishing licence (or have/will make an application for a class 1 commercial fishing licence), and agrees to be registered as an eligible fisher for the above fishing business. A signature is not required to cancel a registration as an eligible fisher for a fishing business.

There can be only one nominated fisher for a fishing business at any given time. A person can be nominated to hold the same endorsement for two or more fishing businesses provided the endorsement is not the quota managed abalone or lobster fisheries. A nomination does not take effect until NSW DPI receives this nomination form and the nominated fisher is in possession of the 'fishing business card'. Fishing business owners are responsible for ensuring that NSW DPI has received the nomination form before the nominated fisher starts working. Once a nomination is made it must remain in effect for a **minimum of 48 hours**. In order to take fish for sale, the nominated fisher must also be in physical possession of their current Class 1 commercial fishing licence. Nominating a new fisher automatically revokes a previous nomination.
