Outcomes from Out of Session Agenda items

Background

Since the last EGMAC meeting held in late 2005, there have been four out of session agenda items relating to closures that have been forwarded to the committee representatives for their consideration. Outcomes from the out of session agenda items are listed below:

Yarrahapinni Closure

The Yarrahapinni closure has been renewed as of 21 July 2006, prohibiting the taking of fish by all methods in the waters of the Yarrahapinni Wetland Reserve. The Yarrahapinni Wetland Rehabilitation Project aims to remove or mitigate drainage works and rehabilitate the 600 hectares to its former seagrass, mangrove and salt marsh communities. This closure aims to improve habitat protection and restoration of the area. The closure has been renewed for 5 years.

Yellowtail Kingfish

The Yellowtail Kingfish closure was reviewed in early 2006. This closure prohibited the retention of Kingfish by the means of all methods other than the hauling net (general purpose), set lines, hand held lines, drift lines and spears.

This closure was primarily implemented to prevent the capture of Kingfish in pelagic fish traps. Clause 59 (d) of the Regulation now prevents pelagic fish trapping by requiring the fish trap to be secured or weighted so that the trap rests on the seabed. As such, the closure has not been renewed and the Department will be closely monitoring the catches of Kingfish.

Australian Salmon and Tailor Closure

The Department is currently reviewing this closure, which is due to expire on the 31 August 2006. The Department will advise the Committee of the outcomes from the review, once available.

Overnight meshing Closure for selected areas of the Tweed and Shoalhaven Rivers

The Department has received comment from the Committee representatives on the proposed closure. The general position from the Committee representatives was to support the position of the MAC representatives in the relevant zones of the proposed areas, i.e. Regions 1 and 6. The Department is currently reviewing the closure in light of comments received.

Issue

Review of the Estuary General Code of Practice.

In April 2005, the Estuary General Code of Practice was finalised and introduced following extensive consultation led by Ocean Watch. It was determined that the Code of Practice should be reviewed in consultation with the EGMAC every two years, with appropriate amendments implemented. The current Code of Practice (CoP) is provided at Attachment 2.

The following issues are provided for consideration:

- 1. The eel consultation paper recommended that codends be required in eel traps to minimise damage to eels and allow for water rats to chew through the soft mesh, if captured. At the last EGMAC meeting it was recommended that codends should be optional in eel traps and a set of guidelines on when and where codends should be required be included in the Code of Practice.
- 2. Minimise noise associated with fishing operations (condition 34 of the CoP). The Department has received numerous calls from the general public complaining about noise associated from splashing operations during general sleeping hours. It is proposed to add to condition 34 of the CoP 'Especially when conducting splashing operations during general sleeping hours from 10pm 5am.

Agenda Item 8c

NSW Department of Primary Industries

Issue

Flathead net replacement and new overnight meshing registration time frame.

Background

In January 2005, the new flathead net and overnight meshing net Regulations were implemented, and fishers were given a few months to register a replacement flathead net and additional overnight meshing net that meet the new specifications. After this timeframe fishers were advised to make an appointment with the local district fisheries officer to exchange/register a new net. No time period was identified for completion of this arrangement.

Departmental response

Compliance Officers have raised concerns with this infinite timeframe. The Department proposes a cut-off date of **30 June 2007**, for fishers to replace their flathead net registrations and obtain a new overnight meshing registration. If supported, a letter will be sent to all meshing endorsed fishers notifying of this date.

Issue

Request to Prawn Seine in the two Rivers adjoining Watson Taylors Lake

Background

The Laurieton Fishermen's Co-operative has requested the Department consider amending the table to Clause 37 of the Regulation, to allow prawn seining in the Rivers adjoining Watson-Taylors Lake. The two Rivers of concern are the Camden Haven and Stewarts River.

Clause 37 of the Regulation provides for the use of seine nets when taking prawns, and the table to the clause authorises the areas for that prescribed operation. The requested amendment relates to table 3(a) of the clause.

The Co-operative requested that 'Rivers' be implemented into the Regulation because fishers have worked these areas unbeknown that it is illegal and the reading of the current table 3 (a) in the Clause is ambiguous. The Co-operative also claims that there is little conflict with other stakeholder groups in the proposed area.

Departmental Response:

The current terminology of Clause 37 prohibits the use of prawn seining in Rivers. The water in the table have not been amended since the *Fisheries and Oyster Farms (General) Regulation* 1985. Furthermore, fishers currently have the opportunity to target prawns in these rivers through other fishing methods i.e. prawn hauling and may target prawns by prawn seine nets in the Lake.

Issue

Region 1 Fishers have proposed to authorise unlicenced crew for Prawn Hauling Operations in the Richmond River.

Background

Under clause 146 (c) of the *Fisheries Management (General) Regulation 2002*, a prawning endorsed fisher may have an unlicenced crew member on the boat when the boat is used to take prawns from estuary waters (but not from the shore) by the use of a seine net (prawns). The Region 4 (South) EGMAC representatives, on behalf of the prawn haulers in the Richmond River (Region 1) has requested the Department consider allowing unlicenced crew (or licenced commercial fishers without a prawning endorsement) on onboard boats during prawning hauling operations in the Richmond River.

Reasons for the request are:

- There are limited numbers of prawning endorsed fishers to double up in the Region since the Cape Byron Marine Park buyout
- A crew person increases safety during the operation

Department Response.

Departmental records indicate that there are 22 fishers with Estuary General prawning endorsements in Region 1. The Department notes that this proposal will allow for an increase in effort, illegal activity and issues for compliance. The possibility of allowing licenced (but not prawning endorsed) commercial fishers onboard a vessel when conducting prawning operations has also been considered. Again this has the potential to increase effort and impact on compliance.

Attachment 2: For Agenda Item 7, review of the Estuary General CoP

NSW Estuary General Fishery Fishers Code of Practice for use of fishing methods other than prawn trawling nets in NSW estuaries

The NSW Estuary General Fishery is subject to rules as specified in the *Fisheries Management Act 1994*, the *Fisheries Management (General) Regulation 2002* as well as closures and licence conditions under the Act, which allow enforcement of the operating standards in the fishery. Fishers are also required to comply with a range of other Local, State and Commonwealth statutory requirements. For further details refer to *NSW Estuary General Fishery Management Strategy*.

In addition to these regulations and conditions, many commercial fishers have expressed their commitment to take on greater responsibility and accountabilities for sustainable fisheries management.

The Estuary General Code of Practice summarises the broad principles under which fishers operate. This Code applies to fishers using a variety of fishing methods in NSW estuaries (see NSW Estuary General Fishery Management Strategy for further details).

Please note that the term "fish" refers to all organisms that may be taken, or interacted with, by estuary general fishers, including finfish, prawns, crabs, pipis, beach worms, eels, invertebrates and sessile creatures.

As a person participating in the NSW Estuary General Fishery I will:

- 1. Conduct fishing operations in a way that minimises disturbance to nesting and feeding sites of migratory and resident shorebirds.
- 2. Minimise the need to tie up to mangroves and other riparian vegetation.
- 3. Responsibly dispose of any litter or derelict fishing gear, either generated or collected in fishing operations.
- 4. Conduct fishing operations, and maintain fishing boats and vehicles, in a manner that minimises emissions, and water pollution.
- 5. Obtain all permits required by the local Council, NPWS or private land owners for accessing fishing grounds, use only authorised access points (if designated), and comply with any agreements relating to the use of keys, gates and closures.
- 6. Work with local Councils to signpost entry and exit points used to access fishing grounds.
- 7. Avoid using prawn hauling nets, hand hauled prawning or prawn seining nets over areas of seagrass.
- 8. Avoid using hauling nets over areas of Strapweed seagrass (Posidonia australis).
- 9. Observe all size limits for permitted species as set out in the regulations.
- 10. Ensure that true and accurate records of fish landed for sale are maintained and submitted in accordance with the Act.
- 11. Ensure that all permitted fish landed for sale are marketed in an authorised manner.
- 12. Conduct fishing operations in areas, at times, and in a manner, that minimises levels of bycatch.
- 13. Use equipment (such as swim tanks or exclusion devices) or methods (such as sorting catch while the net is still in the water or giving immediate priority to return bycatch to the water) that minimise bycatch levels, mortality and stress, and minimise the opportunity for scavenging by birds.
- 14. Promptly return the unwanted portion of any prawn catch to the water uncooked as soon as practicable, ensuring the least possible harm.
- 15. Use any implement necessary to ensure crew safety when sorting catch (such as large tongs), but not implements (such as a spike or club) that could pierce, beat or otherwise injure any fish or animal taken in the catch.
- 16. When using mesh nets or flathead nets, return bycatch to the water using an approved design of discard chute during specified hours.
- 17. Be familiar with the list of, and methods of identifying, protected species and threatened species, populations and ecological communities that might be encountered during fishing operations.
- 18. Conduct fishing operations in areas, at times, and in a manner that minimises the potential for any interaction with protected species or threatened species, populations and ecological communities.

- 19. Report the location, time and date, in the comment section of the estuary general monthly catch return, or other appropriate logbook, of any interaction with, or sighting of, individuals of marine protected species or threatened species, populations and ecological communities or any interactions with threatened or protected sea birds.
- 20. Return any captured individual of a protected species or a threatened species, population or ecological community to the water with the least possible harm.
- 21. Suspend the fishing operation if a cetacean (whale or dolphin) or turtle is captured, and allow the release of the animal from the net with the least possible harm.
- 22. Deploy and retrieve gear in accordance with regulations.
- 23. Ensure fishing operations are conducted with an acceptable level of safety for fishers and the public.
- 24. Comply with the instructions of the NSW Food Authority regarding the handling of fish and effective icing and storage to maximise the quality of product and minimise food safety hazards.
- 25. Be licensed by the NSW Food Authority, and have in place a Food Safety Plan to minimise food safety hazards associated with the harvest of all fish for human consumption.
- 26. Recognise and abide by the priority rights among commercial fishers as set out in regulations or any other guideline approved by the Estuary General Management Advisory Committee (EGMAC).
- 27. Be courteous to other waterway users when exercising priority rights.
- 28. If necessary, produce my fishing license, or authority to fish, to ensure the required number of endorsed fishers for priority determination are present.
- 29. Unless otherwise authorised, abide by a limit of 30 km/hr on beaches, and a limit of 5 km/hr when passing within 10 metres of other beach users or flagged areas.
- 30. Operate flashing lights or hazard lights on the vehicle while travelling on ocean beaches.
- 31. When travelling, or engaging in commercial fishing, on ocean beaches, display a NSW Department of Primary Industries authorised information sign containing my name, commercial licence number, vehicle registration number, endorsement type and region.
- 32. Avoid driving vehicles on frontal sand dunes or other sensitive shoreline areas such as wetlands and mangroves and minimise, as far as practicable, any physical impact on the environment.
- 33. Keep hand held lights at water level so that they are not shone into residential areas.
- 34. Minimise noise associated with fishing operations.
- 35. Respect the public amenity of boat ramps by avoiding cleaning fish and gear in their vicinity and ensuring that access for other users is not unduly restricted.
- 36. Be aware of any changes to the *NSW Estuary General Fishery Code of Conduct* or regulations applicable to the fishery, and keep a current copy and any applicable regional supplements in my vehicle or boat.
- 37. Be aware of Indigenous culture in my area of operations, and respect the customs of the local Indigenous people.
- 38. Be pro-active, cooperate and assist with investigations relating to:
 - Identification and mapping of significant habitat and areas of environmental sensitivity
 - Gear modification for bycatch reduction
 - Sustaining fish stocks
 - Minimising interactions with threatened and protected species
 - Efficiency of fishing gear and operations
 - Any other relevant research programs
- 39. Inform the relevant authority of any pollution incident or significant environmental impact.
- 40. Comply with the by-laws and regulations of relevant local Councils, NPWS, NSW Food Authority and Waterways Authority, and any codes for fishers prepared by these organisations that are supported by the EGMAC.
- 41. Be courteous and cooperative with any public official or member of the community.
