## **IMPORTANT INFORMATION**

If applying to replace a licensed fishing boat and the application is approved, a new LFB number will be allocated. If applying for the identifying particulars for a boat to be changed because the boat has been modified, the same LFB number will be retained.

It is a condition of all fishing boat licences that a boat is not used to take fish for sale unless the boat's identifying particulars are noted on the boat's licence, and that a boat is not to be modified in such a manner that affects its length, hull units or engine power if those particulars are noted on the licence, unless application has been approved for those particulars to be changed.

If a licensed fishing boat is disposed of, destroyed or lost at sea, the licence holder is required to notify the NSW Department of Primary Industries within 30 days. The fishing boat licence will then be placed in voluntary suspension. Fishing boat licence fees remain payable while a licence is in voluntary suspension. If applying to replace a boat whilst the fishing boat licence is in voluntary suspension, the voluntary suspension will automatically be lifted.

If the application is made by a partnership, all partners must sign the application. If the application is made by a company, the application must be signed by someone with authority to sign on behalf of the company, and the signatory's full name and company position held must be provided.

### **Boat details verification for replacement boats**

In accordance with Clause 159A of the *Fisheries Management (General) Regulation 2002*, the dimensions of a replacement boat are to be determined in accordance with the Uniform Shipping Laws (USL) Code. If a survey certificate has been issued for the boat, the dimensions recorded on the current NSW Maritime survey certificate will be taken to be the dimensions of the boat. Otherwise, the dimensions of the boat must be verified by the District Fisheries Officer or certification by a marine surveyor prior to submitting this application. If upon replacement or modification the dimensions of a boat do not meet the maximum boat specifications appearing on the fishing boat licence, the application will be refused.
