# 24 November 2022 – Meeting opened 08:45am

# 1. Member Welcome, Introductions and Housekeeping

#### NOTED:

- The Chair welcomed Council members, guess and NSW DPI staff.
- The traditional owners of the land, past, present, and emerging were acknowledged.

#### 2. Review of Agenda

Council accepted the agenda.

#### 3. Review, declarations, and update register of interests

# NOTED:

It was noted that the pecuniary interest register was updated prior to the meeting.

**ACTION:** Executive Officer to update pecuniary interests register and circulate (permanent action).

#### 4. Confirmation of Minutes from Meeting 24

#### NOTED:

The minutes for meeting 24 were accepted as a true and accurate record of the meeting.

# 5. Current actions arising from Meeting 24

# NOTED:

- Action 14.6 has been superseded (refer now to 24.7).
- The following actions have been completed: 14.6, 22.2, 24.1, 24.3, 24.4, 24.5, 24.8, 24.9.
- All other actions are in progress.

#### 6. Correspondence received

#### NOTED:

Correspondence was received thanking DPI staff for listening and taking in views on the Draft NSW Sustainable Commercial Fishing Strategy. Correspondence regarding progress on specific BEP submission sent to NSW DPI for response.

# 7. Stay Afloat (Jo Marshall)

The Council received a presentation on the Stay Afloat program.

# NOTED:

- A national mental health and wellbeing pilot program for the Australian seafood industry, run by Seafood Industry Australia (SIA)
- Funded by the Australian Government Department of Health's Mental Health Program

- The program is a three-stage approach:
  - 1. Three trusted industry advocates from each piloted area will receive mental health first aid training. They will be given resources to act as mental health support coordinators on the ground.
  - 2. Mental health first aid training will be provided to the national seafood community.
  - 3. Grants for events to support seafood industry led gatherings to provide mental health and wellbeing information.
- Further information can be found at <u>Stay Afloat</u>.

# 8. Deputy Director General update

The Deputy Director General provided the following summary:

- Stuart Richey AM was congratulated on his re-appointed to the position of CommFish NSW Chairman.
- Fisheries Act amendment bill relating to the definition of a premises and Compliance Officer's powers of search have been through Parliament.
- The Commencement of the Fisheries Management Amendment Act 2009 (Cultural Fishing) Parliament enquiry has been published.
- Boat length changes and 10-year license have been through consultation and regulation changes are being prepared.
- Southern Fish Trawl fishery update: Federal Government have honoured the buyback for Southern and Eastern Scalefish and Shark Fishery. The federal timeline is set for the beginning of the quota year (May 2023).
- The spanner crab harvest strategy has been released for consultation.
- It was raised that harvest strategies would benefit from having a CommFish member on the working group to assist in the flow of information to the advisory council. The members discussed the importance of the harvest strategy working group liaising with CommFish, whether that be through membership or other methods.
- It was ask when the outcome of the marine park zoning plans will be available, with a reference to Batemans Bay. The DDG notes that the plans are still pending finalisation before broader feedback and consultation.

# 9. Aboriginal Harvest Strategy Framework project update (Dr Ian Knuckey)

# NOTED:

- Project does not include commercial Aboriginal fishing
- Linked with Aboriginal Fishing Advisory Council (AFAC) members and process
- Currently reviewing literature and project ethics

# 10. Workshop on fisheries population dynamics and harvest strategies (Dr. Ian Knuckey)

# NOTED:

• Dr Knuckey's plain English explanation on the contents a harvest strategy was very well received.

**ACTION 25.1**: It was recommended to NSW DPI to consider introducing the presentation by Dr Knuckey on harvest strategy (HS) components to become part of the induction for new HS working groups.

# 11. Program Leader, Commercial Fishing update

- The NSW Sustainable Commercial Fishing Strategy 2022-25 has received minor amendments.
- A general update was provided on the Business Efficiency Program.

# 12. Debrief from meet and greet with industry – 23 November 2022

It was noted the attendance by industry was encouraging. Many questions were address on the spot and others noted for follow up with DPI NSW and the attendees.

# **13.** Recreational Fishing Environmental Assessment update (Phil Bolton)

Council was advised that the social and environmental draft has been completed.

# 14. MFAC member update and insight (Greg Finn)

The MFAC member summarised the five top priorities that he has worked on over his tenure, further details can be found at appendix B.

# NOTED:

• The Council unanimously supported the current MFAC member to reapply for the MFAC position which is due to expire at the end of January 2023.

# 15. Shark Program and SharkSmart App discussion (Marcel Green)

Council was provided with information on the SharkSmart app and on the Shark Management program – increased protection for beachgoers from shark interactions while minimising harm to sharks.

#### NOTED:

- Council noted that further information can be found at <a href="https://www.sharksmart.nsw.gov.au/current-program">https://www.sharksmart.nsw.gov.au/current-program</a>
- It was mentioned the V1 100 acoustics system indicates when a tagged shark is close. Abalone member mentioned that they use a Succorfish system that can also be upgraded to include acoustics.
- The Abalone Members to liaise with the Sharks Program Leader member to provide further information on the Succorfish system, to investigate whether industry and the community would benefit from divers incorporating the acoustic system into their operations (industry specific).

# 16. Shellfish Committee and topics of concern (Ian Lyall)

# NOTED:

- Shane Buckley was introduced as a member from the Shellfish committee
- It was recommended at the Shellfish committee that water quality issues, that affect all marine users, could be worked through in conjunction with the other Ministerial Advisory Councils to ensure all issues are addressed

- Marine Estate Management Strategy does not mention food production, the Shellfish committee is seeking support to ensure water quality is captured
- ACTION 25.2: CommFish supported the Abalone member to work with the Shellfish committee on the water quality issues from a wild catch perspective.

# **17. Program Leader, Resource Management update**

Approval is pending for the Line and Trap Harvest Strategy Working Group (HSWG)

The Mulloway Harvest Strategy working group is at the point of providing the more difficult input of developing the harvest strategy. The working group will not meet again until the new year.

#### NOTED:

- Free flow of information is important to CommFish, and from experience it has been beneficial to have a member on Harvest Strategy Working Groups
- It was recommended that future harvest strategies should be dissected by CommFish through a presentation by NSW DPI

#### ACTION 25.3:

NSW DPI to consider processes to keep CommFish updated on harvest strategy processes, either through idenified CommFish membership on future HSWG's or other specific process to ensure members' ability to undertake due diligence in decision making.

#### NOTED:

# 19. Aboriginal Cultural Fishing Local Management Plan (LMP) update (Carl Bevilacqua)

#### NOTED:

- Consultation has taken place and the Tweed LMP has been implementation. Consultation included targeted engagement with commercial and recreational fishers, the Abalone Association, RFNSW, PFA and advisory committees.
- NSW DPI encourage CommFish to engage with the LMP steering committees.
- Members expressed the desire for early consultation in setting limits in the LMPs to consider quota setting and ensure integration with the science used to manage the fishery from an industry perspective.

# 20. Introduction and presentation – Shape cultural change in the NSW Northern Fish Trawl sector (Dr Gary Saliba)

#### NOTED:

• FRDC have provided funding to examine the cultural interaction between industry and fishing industry, to develop tools to improve future engagement, with the Northern Fish Trawl Sector as the pilot program. The outcome will be to build productive working relations that enable adaptive and transformative change.

- The project will pilot the following approach:
  - identify and explain the current relationship dynamics between industry and regulators affecting collaborative relationships
  - design a suite of projects to transform the relationships to build a trusting and collaborative culture
  - develop the framework and practices for self-perpetuating co-management of fishing resources.
- CommFish members reviewed the list of proposed representatives and considered that there was already a wide range of attendees to support the project.

# 22. Parks Australia – VMS program – Australian Marine Parks (AMP) (Andrew Coleman, Barbra Musso)

# NOTED:

- Parks Australia have proposed that all commercial fishing vessels transiting or operating in an AMP will be required to have VMS by 01 July 2024.
- VMS is viewed as a cost-effective tool to demonstrate marine park users are following the rules. The system has automated alerts for skippers, owners and regulating agencies to providing warnings of when a vessel are in the vicinity of no fishing zones.
- Other benefits VMS is that it improves the transparency of operations in a public space, demonstrate fish activity abides by the rules and a will increase data available to support compliance rates and is being used more to contribute to stock assessments.
- NSW DPI has been successful in obtaining a grant to support NSW industry in any transformation
- Important dates provided:
  - December 2022- March 2023 Consultation on the requirement for VMS in AMPs.
  - April 2023 Parks Australia will review the feedback and prepare the draft class approvals
  - Target 01 July 2024 for requirement for VMS to be operating on vessel entering an AMP.

# 23. FishOnline Modernisation Project (DRF) (Aimee Cavanagh)

# NOTED:

An update was provided by DPI NSW on the FishOnline Modernisation Project. The department are looking to improve the system by making it simpler to use, hence reducing reporting time burden and improving data accuracy.

Members provided feedback on the current system, and expectation on improvements to

the proposed new system.

Members agreed to provide their contact details to provide further input when required.

### 24. General Business

### <u>Topic</u>

DPI NSW sought practical feedback on the marking requirements of an unattended prawn pocket set net ( as per a BEP proposal).

**ACTION 25.6:** It was recommended to DPI NSW that a buoy (not less than 200mm) should display the Fishing Business number and be accessible downstream of the net.

# <u>Topic</u>

It was confirmed that there is no intension to change the yabby trap type used in the commercial inland fishery in the near future.

# **Topic**

Due to potential growth in the SUTS fishery the potential of transitioning the SUTS fishery to a share management fishery was raised as an opportunity. The MFAC member and the SUTS member declared their interest and refrained from the discussion.

DPI NSW suggested that the SUTS industry endorsement holders need to work together to ensure common ground and endorsement holder support before approaching the government to initiate any processes.

# <u>Topic</u>

It was raised that some feedback to CommFish members and members were challenged by the useability of SFM blue. To contribute to improving the program it was suggested members summarise their issues and share with the operators.

**ACTION 25.7:** EO to collect SFM Blue items from CommFish members and provide to Chair for consideration share with SFM Blue operators.

#### **Topic**

It was noted that six CommFish positions will become vacant on the 30 November 2022. Members were encouraged to reapply or inspire other candidates to apply for the vacancies.

# <u>Topic</u>

The committee discuss the process on developing the fit and proper person assessment and penalty demerit scheme.

**ACTION 25.8:** Invite NSW DPI Compliance to a future meeting to discuss the progress of the fit and proper person test and penalty demerit scheme.

# **Topics**

It was raised that it may be beneficial to review some proposals that were considered and not supported if more information on the proposal was sought. Previous minutes indicated that CommFish will continue to progress the supported proposals at this time, recognising that the current program is unlikely to be the only opportunity for future business efficiency improvements.

# Ministerial Fishing Advisory Council (MFAC) Commercial Fisher representative update.

# Background

Back in February 2020, I (Greg Finn) accepted the position as the Commercial Fisher on MFAC with the intention to establish cohesive collaboration and backing to the commercial fishing industry. As a member on this council, it also has given me the opportunity to represent MFAC on the Commercial Fishing NSW Advisory Council.

# **Summary**

It has been a successful tenure working in collaboration with both councils. It has allowed the opportunity to network, support and have input into the achievements of both councils. Listed below but not limited to are key topics since February 2020.

# **Key Topics**

1. Regulatory Reform

BEP completion of first round of measures delivered. Second round currently being put out for consultation.

2. Agreed Cost Recovery

2-year trial applied to quota/ effort shares and endorsements.

3. Workable HS Development

Mulloway underway, completed for trawl whiting, Eastern Rock Lobster and Spanner Crab.

- 4. Cultural Fishing Policy
