FORM L: Animal Use Statistics 2010 Explanatory Notes What is Form L?

Form L is the format in which the Animal Welfare Unit of Industry and Investment NSW collects information on Animal Ethics Committee (AEC) activity and animal use in research and teaching which occurred in NSW during the calendar year (ie 1 January to 31 December). Under the Animal Research Act 1985 this information must be submitted by all accredited animal research establishments and holders of Animal Research Authorities by 31 March of the following year.

- Form L Section A: Animal Ethics Committee Activity Report
 This section requests information regarding Animal Ethics Committee (AEC) activities and provides an opportunity to report on the implementation of the principles of Replacement, Reduction and Refinement.

- 4. Number of projects approved
- 5. Number of projects rejected

Purpose of Annual Report

- To encourage self assess compliance with the animal research legislation
 Specifically: review activities and operations
- Advise managers of the establishments of activities and identify measures needed to ensure ongoing compliance
- ARRP has developed a template covering all aspects of the policy to assist in this process and provide more consistent and relevant feedback

Annual Reports 2009

- 13 Did not address all reporting criteria or provide sufficient information for independent evaluation
- 14 Addressed all reporting criteria but provided insufficient information for independent evaluation
- 13 Were comprehensive but failed to report information on high impact studies
- 13 Comprehensive addressing all criteria in detail

High Impact Studies

Category 7: Major Physiological Challenge

Animal remains conscious for some or all of the procedure. There is interference with the animal's physiological or psychological processes. The challenge causes a moderate or large degree of pain/distress which is not quickly or effectively alleviated.

Categtory 8: As An Endpoint

This category only applies in those rare cases where the death of the animal is a planned part of the procedures and animals die but are not euthanased. Where predictive signs of death have been determined and euthanasia is carried out before significant suffering occurs, they may be placed in category 6 or 7.

The information should include measures implemented to reduce the number of high impact projects approved and to reduce the number of animals used in high impact projects.>>
- Physical facilities for the care and use of animals by the establishment
- << In accordance with Clause 2.2.40(ii) of the Australian Code of Practice for the Care and Use of Animals for Scientific Purposes comment on the adequacy of facilities for animal care and use.>>
- 6. Activities that have supported the educational needs of AEC members, and of personnel involved in the care and use of animals
