The original document that embodies the mortgage/interest transaction must be submitted with this application, along with a certified copy. Upon completion of the transaction, the original document will be returned to the Mortgagee or other interest holder with a certified copy retained by the Department.

Shares Subject to Appeal

Mortgages/interests will not be registered for restricted fisheries endorsements.

Partnerships

If the applicant is a partnership, all named licence holders must sign. If a company, the application must be signed by someone with authority to sign on behalf of the company, and the signatories full name and company position held, must be provided.
