Mortgage/Interest Registrations

The original document that embodies the mortgage/interest transaction must be submitted with this application, along with a certified copy. If a mortgage, the mortgage documents must show evidence that the Office of State Revenue (OSR) has stamped the document for payment of mortgage stamp duty. Upon completion of the transaction, the original document will be returned to the Mortgagee or other interest holder with a certified copy retained by the Department.

Shares Subject to Appeal

Mortgages/interests will not be registered for restricted fisheries endorsements.

Partnerships

If the applicant is a partnership, all named licence holders must sign. If a company, the application must be signed by someone with authority to sign on behalf of the company, and the signatories full name and company position held, must be provided.
