

## NSW Native Game Bird Management (Owner/Occupier) Licence

SunRice and DPI Hunting have a licensing partnership that streamlines the process for you to apply for a Native Game Bird Management (Owner/Occupier) Licence (NGBML) through your annual *Rice Seed Order & Paddy Supply Offer*.

Please read through the information below for how to apply for or renew a NGBML that authorises the sustainable management of native game birds, by NSW Game Hunting Licence holders only, on your agricultural land in NSW.

**To apply, you must:** acknowledge the declaration points below are correct *by ticking* the YES answer box, and select a property allocation option (1, 2 or 3) on each *Rice Seed Order Form & Paddy Supply Offer* you submit.

**Important information:** NGBML's are issued for a maximum duration of one year and expire on 31 August each year.

DPI Hunting will determine an appropriate allocation to apply across the total of your properties listed under a NGBML, which may include assessing previous hunter harvest return data and historical impacts.
