Reissue of a charter fishing licence may be refused for reasons shown in Clause 208 *Fisheries Management (General) Regulation 2019*.

(a) the applicant has been convicted of an offence –

(i) under the Act or the regulations, or

(ii) relating to commercial or recreational fishing under a law of the Commonwealth, another State or Territory or New Zealand, or

(iii) relating to the theft of fish, fishing gear or a boat or intentional damage to fishing gear or a boat, or (iv) relating to an assault on a fisheries official, or

(b) the applicant has previously held a licence that has been suspended or cancelled by the Minister, or (c) the applicant is not the owner of a charter fishing business, or

(d) approving the application would result in more than 1 licence being held in connection with a recognised charter fishing business.

Note: Licences issued by DPIRD Fisheries do not authorise boats to operate without relevant Australian Maritime Safety Authority certificates of survey.

Privacy notice:
