12 June 2014

1. Chairs introduction

The Chair welcomed members to the meeting.

2. Apologies

Lisa Terry (Region 2), John Featherstone (Region 3), Stuart Rhodes (Region 6b), David Jones (gamefishing).

3. Confirmation of outcomes from previous RFSTEC meeting

The draft outcomes of the 40th RFSTEC meeting were accepted as a true and accurate record of the meeting. Moved: John Paton. Seconded: John Burgess. Carried.

4. Action items from previous meetings

The Committee noted the progress on action items from the previous meeting.

5. Recreational Fishing Trust report

The status of the Saltwater Trust was presented. Meeting reports for Trust funded programs were submitted by project managers to enable committee members to review progress of projects prior to the meeting. DPI advised that the number of electronic licence sales continues to increase with a corresponding decrease in manual methods, such as licence agents. The Government Licensing Service has also recently launched a smartphone application for purchasing and renewing a fishing licence, which includes a facility to store your licence on your phone. DPI also advised that the Independent Pricing and Regulatory Tribunal (IPART) has completed a statewide review titled: Reforming licensing in NSW. The review aims to identify all licence types in NSW and prioritise those where reform would produce the most red tape savings. Recreational fishing licences were included in the review and IPART recommended that: By end of 2014, the Government should review the recreational fishing licence using the Licensing Framework with respect to duration, fee setting and administration. DPI will be undertaking the review as recommended.

Action item – RFSTEC recommends that ACoRF provide a submission to the IPART review. Moved Malcolm Poole, Seconded Ann Garard, Carried.

Community EOI for Trust programs

A community expression of interest for Trust funded programs was advertised by the Department and widely circulated using a media release, Newscast, mail outs to fishing clubs, councils, the Department's

website and other networks. The closing date for submission of new applications was Monday 14 April 2014. Over 50 applications were received by DPI.

Ongoing promotion of recreational fishing trust programs

The Committee was advised that the 2014 saltwater and freshwater recreational fishing guides fishing had been reprinted and distributed through the various networks during the busy Easter fishing period, including licence agents, Fisheries Officers and Fishcare Volunteers. It is proposed that another Trust promotional video be produced to enhance community awareness of Trust programs and initiatives. The DPI website will also be updated to show a geographical distribution of fishing licence expenditure in NSW. A DPI Fisheries Facebook page is also being used to promote recreational fishing articles, including programs funded by the Recreational Fishing Trusts.

Action item - DPI to distribute recreational fishing guides to expenditure committee members.

Action item – The Chair write to the various parties involved in the Lagers Point boat ramp project congratulating them on the timely and successful completion of the project.

6. Strategic fisheries research plan

DPI advised the Fisheries NSW Strategic Research Plan 2014-2018 has been developed and published. The strategic plan provides a framework to guide the development of future research projects across a range of priority programs, which include threats to fishery resources; sustainable fish harvest; ecosystem assessment; aquatic biodiversity; sustainable aquaculture; fishery enhancement and fish habitat improvement.

A table of recreational fisheries research priorities previously developed by ACoRF, as part of the previous research strategy titled: Planning Strategic Research for Wild Fisheries, Aquatic Ecosystems and Aquaculture in NSW (updated in 2011), was provided to members. This previous strategy contains a series of priorities previously identified by recreational, commercial, aquaculture, research and conservation consultative committees (note: many of the priorities were jointly identified by various consultative committees).

It was noted that many of the research topics listed in the table had been completed or were underway. The Chair invited committee members to submit specific priorities for the development of a new recreational fishing stakeholder research priority list for 2014 and beyond. A template for listing new research program priorities was distributed to committee members.

Action item - RFSTEC to submit any specific coastal stakeholder research priorities by the next RFSTEC meeting.

7. Review of new 2014/15 Trust funding applications

The committee reviewed new Saltwater and joint Freshwater/Saltwater Trust grant applications (large and small grants). Funding recommendations with respect to each project will be forwarded to ACoRF for subsequent recommendations to the Minister for consideration. Meeting recommendations are provided in Tables 1 to 4.

Action item – RFSTEC recommends that ACoRF write to the Minister to request a review of the Fisheries Scientific Committee process in terms of their jurisdiction over issues in Commonwealth waters.

8. Project update: Closing the loop

Project officers from the University of NSW provided an update on the Trust project titled: Closing the loop: Understanding the relationships between recreational fishing surveys, fishing regulations and fisheries management objectives. The Committee noted that the Management Strategy Evaluation model had been completed, which could now be applied to various management scenarios for analysis.

9. Project update: Get hooked...it's fun to fish update

A total of 95 schools have registered for the Get Hooked program in 2014 with over 4840 school students participating this year, including a large number of schools in regional inland areas. A new Get Hooked teachers manual was launched in 2014. A Get Hooked Crab Mascot naming and colouring in competition was held for all registered schools to promote interest in the program. The end of year Get Hooked fishing workshops were run over an 8 week period including 3 new fishing locations: Jervis Bay; Ballina and Wee

Jasper. The fisheries advisory trailer was used at the Sydney Royal Easter Show and over 81,000 contacts were made during the 14 day event.

Action item – New Get Hooked manual to be sent to committee members.

10. Project update: Fisheries enhancement

DPI advised that following completion of the Environmental Impact Statement for marine stocking, it is proposed to implement a small scale stocking program later this year, which will include the stocking of Eastern king prawns. Stockings will have an associated research and monitoring program. An analysis of listed waterways are being reviewed for suitability.

DPI advised that the past FADs season was very successful based on angler catch reports. The FADs are progressively being removed for winter maintenance. Good catches of dolphinfish have been recorded on all FADs, including the far south coast. It was reported that the tender for the Shoalhaven offshore artificial reef had been released and that constraints mapping to assist with site selection for the Port Macquarie offshore reef was underway.

The NSW Minister for Primary Industries, the Hon. Katrina Hodgkinson, also recently announced that two new offshore artificial reefs will be built off the coast of Port Botany. The reefs will be funded under a \$5 million Port Botany Boating and Fishing Infrastructure Program and will be constructed using large concrete modules. A new fishing platform, to provide an all-weather safe fishing location within Port Botany, will also be constructed from the new program.

Action item – RFSTEC write to Mr Stan Konstantaras, ANSA (NSW) to congratulate ANSA on their efforts to establish two offshore reef and fishing platform projects in the Botany Bay area.
