This application form is for use by shareholders in NSW Fisheries who wish to apply to manually transfer quota between fishing businesses and those NOT electing to use the free online transfer facilities. The application is to be made by the person who proposes to transfer quota (transferor). This form is to be completed in full. The fee associated with this application can be paid by enclosing a cheque, money order, credit card payment form or a cash payment at your local regional office.
