1 Name of notification

This notification is the Fisheries Management (Murray Crayfish - Fishing Closure) Notification 2021.

2 Commencement and duration

- (1) This notification commences on the day on which it is published in the *NSW* Government Gazette.
- (2) This notification remains in force for 5 years commencing on the date of publication.

3 Definitions

In this notification:

Murray crayfish means fish of the species *Euastacus armatus*.

the Act means the Fisheries Management Act 1994.

4 Revocation of the Section 8 Notification - Fishing Closure Murray crayfish (Euastacus armatus)

Pursuant to section 11 of the Act, the Section 8 Notification - Fishing Closure Murray crayfish (*Euastacus armatus*) (n2018-1839) published in *NSW Government* Gazette No 54 of 1 June 2018 at page 3136 is revoked, as is any notification revived as a result of this revocation.

5 Fishing closure

A person is prohibited from taking Murray crayfish from the waters of Old Man Creek.

Part 1 Preliminary

1. Name of order

This Order is the Fisheries Management (Murray Crayfish in Murrumbidgee and Murray River Tributaries) Order 2021.

2. Commencement and duration

- (1) This order commences on the day on which it is published on the website of the NSW Department of Primary Industries.
- (2) This order remains in force for 5 years commencing on the date of publication.

3. Definitions

In this Order:

Murray crayfish means a fish of the species *Euastacus armatus*.

the Act means the Fisheries Management Act 1994.

the Regulation means the Fisheries Management (General) Regulation 2019.

tributary of a body of water includes a creek, stream, gully, inlet, bay, lake, lagoon, dam, reservoir, pond, canal, channel or waterway of that body of water.

Part 2 Special approval for authorised purposes

4. Murray Crayfish

- (1) Despite clause 150 of Schedule 3 to the Regulation, from 1 June to 31 August in each year, a person may take Murray crayfish from the tributaries of:
 - (a) that part of Murrumbidgee River between the Hume Highway road bridge at Gundagai downstream to a line 100 metres upstream of the weir face at Berembed Weir near Ganmain as described in clause 150(1)(a) of Schedule 3 to the Regulation,
 - (b) that part of Murray River between a line 130 metres below the weir face at Hume Weir near Albury downstream to the Newell Highway road bridge at Tocumwal as described in clause 150(1)(b) of Schedule 3 to the Regulation.
