

Priority Determination between fishers using Prawn Running Nets

Shots as Determined 29 September 2023 – Coila Lake to Middle Lake

In accordance with Division 3 of Part 7A of the *Fisheries Management (Estuary General Share Management Plan) Regulation* 2006 the following fishers have been determined as having rights of priority in the setting of Prawn Running Nets between fishers working on the waters to which this Division applies for the fishing period **1 October 2023 to 30 September 2024, unless sooner revoked**. This determination applies to fishers using both staked and/or non-staked (puddling) prawn running nets.




COILA LAKE – Map 1






COILA LAKE – Map 2
