## Chapter 1 Introduction and Preface

This report spans the first series of the Basin Plan Environmental Outcome Monitoring – Fish (BPEOM-F) program, starting in 2014/15 as a pilot and running annually until 2019/2020. Each chapter of this reports on a different New South Wales (NSW) Water Resource Planning Area (WRPA; <u>Figure 1.1</u>). The New South Wales Lower Darling and Murray WRPA was split into two regions for more spatially explicit reporting.



Figure 1.1 Map showing the Water Resource Planning Areas (WRPAs) contained within this report. Other WRPAs not located in NSW are not reported in this document. Note the New South Wales Murray and Lower Darling WRPA has been split into two separate areas for reporting.
