Legislative requirements

Recording of interactions with protected species is a requirement under each Fishery Management Strategy. Each fishing business with endorsement/permits in a commercial fishery must collect information on their interactions with threatened or protected species. To prevent duplicate reporting only the owner or nominated fisher in charge of the vessel or gear for the business should report the interaction.

Please refer to species guide for a description of the relevant species to assist in identification. An interaction is an incident where the animal comes into contact, is entangled or captured during a fishing operation.

Instructions

The 'Threatened and protected species reporting form' is to be used to report interactions you have with species of conservation interest during any fishing operations undertaken over a monthly period.

Please use the fishing method and location codes given on the monthly catch return. The release condition of the species should also be recorded. (see 'Condition Codes' on this form).

There is a requirement to report deaths or injury of any species on this list. Please contact one of the following departments/organisations:
