I, NIALL MARK BLAIR, MLC, Minister for Primary Industries, in pursuance of clause 6C of the Appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*, clause 6C of the Appendix to the *Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006*, clause 5C of the Appendix to the *Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006* and clause 5C of the Appendix to the *Fisheries Management (Ocean Trawl Share Management Plan) Regulation 2006*, make the following Instrument issuing quota shares.

Explanatory note

This Instrument is made under clause 6C of the Appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*, clause 6C of the Appendix to the *Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006*, clause 5C of the Appendix to the *Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006* and clause 5C of the Appendix to the *Fisheries Management (Ocean Trawl Share Management Plan) Regulation 2006*. The object of this Instrument is to issue quota shares to eligible shareholders in the estuary general, ocean hauling, ocean trap and line and ocean trawl fisheries.

Fisheries Management (Issue of Quota Shares) Instrument 2018

1 Name of Instrument

This Instrument is the *Fisheries Management (Issue of Quota Shares) Instrument 2018*.

2 Commencement

This Instrument commences on the date on which it is made.

3 Interpretation

(1) In this Instrument:

EG Plan means the Appendix to the *Fisheries Management (Estuary General Share Management Plan) Regulation 2006*.

eligible shareholder:

- (a) in the case of the estuary general fishery – has the same meaning as in clause 6BA of the EG Plan,
- (b) in the case of the ocean hauling fishery – has the same meaning as in clause 6BA of the OH Plan,
- (c) in the case of the ocean trap and line fishery - has the same meaning as in clause 5BA of the OTL Plan,
- (d) in the case of the ocean trawl fishery – has the same meaning as in clause 5B of the OT Plan.

estuary general fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

ocean hauling fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

ocean trap and line fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

ocean trawl fishery means the share management fishery of that name, as described in Schedule 1 to the Act.

OH Plan means the Appendix to the *Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006*.

OTL Plan means the Appendix to the *Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006*.

OT Plan means the Appendix to the *Fisheries Management (Ocean Trawl Share Management Plan) Regulation 2006*.

quota shares:

- (a) in the case of the estuary general fishery – means the quota shares listed in clause 6A(1)(d) to (g) of the EG Plan.
- (b) in the case of the ocean hauling fishery – means the quota shares listed in clause 6A(1)(b) to (d) of the OH Plan.
- (c) in the case of the ocean trap and line fishery – means the quota shares listed in clause 5A(1)(b) to (g) of the OTL Plan.
- (d) in the case of the ocean trawl fishery – means the quota shares listed in clause 5A(1) of the OT Plan.

the Act means the *Fisheries Management Act 1994*.

the Regulations mean the *Fisheries Management (General) Regulation 2010*, the EG Plan, the OH Plan, the OTL Plan and the OT Plan.

- (2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act or the Regulations have the same meaning in this Instrument.

4 Issue of quota shares to eligible shareholders in the estuary general fishery

Pursuant to clause 6C(1) of the EG Plan, the quota shares specified in Column 4 of the Schedule to this Instrument, in the share class described opposite in Column 3 of that Schedule, are issued to eligible shareholders in the estuary general fishery named opposite in Column 2 of that Schedule.

5 Issue of quota shares to eligible shareholders in the ocean hauling fishery

Pursuant to clause 6C(1) of the OH Plan, the quota shares specified in Column 4 of the Schedule to this Instrument, in the share class described opposite in Column 3 of that Schedule are issued to eligible shareholders in the ocean hauling fishery named opposed in Column 2 of that Schedule.

6 Issue of quota shares to eligible shareholders in the ocean trap and line fishery

Pursuant to clause 5C(1) of the OTL Plan, the quota shares specified in Column 4 of the Schedule to this Instrument, in the share class described opposite in Column 3 to that Schedule, are issued to eligible shareholders in the ocean trap and line fishery named opposite in Column 2 of that Schedule.

7 Issue of quota shares to eligible shareholder in the ocean trawl fishery

Pursuant to clause 5C(1) of the OT Plan, the quota shares specified in Column 4 of the Schedule to this Instrument, in the share class described opposite in Column 3 to that Schedule, are issued to eligible shareholders in the ocean trawl fishery named opposite in Column 2 of that Schedule.

Schedule Quota shares issued in the estuary general, ocean hauling, ocean trap and line and ocean trawl fisheries

In this Schedule the share class codes set out in Column 3 have the following meanings:

ASARD means ocean hauling – Australian sardine quota shares – see clauses 5(g) and 6A(1)(b) of the OH Plan.

BEYE means ocean trap and line – blue-eye trevalla quota shares – see clauses 4(i) and 5A(1)(c) of the OTL Plan.

BFLAT means ocean trawl – bluespotted flathead quota shares – see clauses 4(f) and 5A(1)(b) of the OT Plan.

BGRO means ocean trap and line – bass grouper quota shares – see clauses 4(h) and 5A(1)(b) of the OTL Plan.

BMACK means ocean hauling – blue mackerel quota shares – see clauses 5(h) and 6A(1)(c) of the OH Plan.

BOPER means ocean trap and line – bigeye ocean perch quota shares – see clauses 4(m) and 5A(1)(g) of the OTL Plan.

BWORM means estuary general – beachworm quota shares – see clauses 5(n) and 6A(1)(e) of the EG Plan.

COCKL means estuary general – cockle quota shares – see clauses 5(o) and 6A(1)(f) of the EG Plan.

HAPU means ocean trap and line – hapuku quota shares – see clauses 4(k) and 5A(1)(e) of the OTL Plan.

LGEM means ocean trap and line – gemfish quota shares – see clauses 4(j) and 5A(1)(d) of the OTL Plan.

NIPPR means estuary general – ghost nipper quota shares – see clauses 5(p) and 6A(1)(g) of the EG Plan.

OTPE means ocean trawl – prawn effort quota shares – see clauses 4(j) and 5A(1)(f) of the OT Plan.

PIPI means estuary general – pipi quota shares – see clauses 5(m) and 6A(1)(d) of the EG Plan.

PLING means ocean trap and line – pink ling quota shares – see clauses 4(l) and 5A(1)(f) of the OTL Plan.

STREV means ocean trawl – silver trevally quota shares – see clauses 4(h) and 5A(1)(d) of the OT Plan.

TFLAT means ocean trawl – tiger flathead quota shares – see clauses 4(e) and 5A(1)(a) of the OT Plan.

TGEM means ocean trawl – gemfish quota shares – see clauses 4(i) and 5A(1)(e) of the OT Plan.

TWHIT means ocean trawl – trawl whiting quota shares – see clauses 4(g) and 5A(1)(c) of the OT Plan.

YSCAD means ocean hauling – yellowtail scad quota shares – see clauses 5(i) and 6A(1)(d) of the OH Plan.
