

Rehoming agreement

Section 54C of the *Animal Research Act 1985* requires authorised persons (accredited research establishments or the holders of animal research authorities) to take all reasonable steps to rehome a dog or cat kept for use in research with a suitable individual or an animal rescue organisation. Section 54A defines "animal rescue organisation" and "suitable individual" as follows:

animal rescue organisation includes an animal shelter, foster carer or foster care network that provides temporary care for an animal for the purpose of finding a new home for the animal.

suitable individual means an individual who —

- (a) agrees to provide an animal with a home and appropriate care, and
- (b) agrees to not keep the animal for animal research, and
- (c) meets criteria prescribed by the regulations for the purpose of this definition.

The NSW Department of Primary Industries and Regional Development's and Animal Research Review Panel's *Guideline for compliance with the Animal Research Amendment (Right to Release) Act 2022* outlines additional criteria that suitable individuals should also meet. The guideline also recommends that authorised persons collect a declaration to ensure they are a suitable individual in accordance with the *Animal Research Act 1985* and the additional criteria recommended in the guideline.

Authorised persons must also ensure that records are kept of the details of the suitable individual or animal rescue organisation with whom the animal has been rehomed, in accordance with section 54F(c) of the *Animal Research Act 1985*. It is recommended that all records are kept for 7 years.

This form is a template that authorised persons can use to collect a declaration from a suitable individual, and the details of the individual. A separate form should be completed for each animal to be rehomed.

This form can also be used as a "Rehoming Agreement" if part 5 is also completed by the authorised person, confirming transfer of ownership of the animal to the suitable individual or animal rescue organisation.
