IMPORTANT INFORMATION

- The applicant must be the holder/s of the licence. The application must be signed by all the licence holders.
- A residential address or, if a company, the registered company address, must be stated, If the applicant is a partnership only one addresses should be listed, If the partners have different postal address a single address must be agreed between the partners and that address should be stated on the application.
- Payment for the annual charter fishing boat licence fee may also apply. If you are uncertain as to whether payment of this fee is required, please contact the Charter Fishing Boat Licensing Section on 1300 720 662.
- Charter fishing boat licence expiry dates are not altered during a boat replacement and carry over to the amended licence.
- The type of authorised activities claimed on a charter fishing boat licence depend on the type of survey held by the original vessel which was used to satisfy the eligibility criteria and qualify for a licence in the first instance. That is, if the vessel that was used to qualify for a licence had historically operated in estuary waters, while your new vessel is authorised to operate in estuary and offshore waters, you are only eligible for the approved activity of estuarine fishing (not the offshore activities).
- It is a policy of NSW DPI that the charter fishing industry will consist of charter fishing boats only, with no dual licensed operations. NSW DPI will not approve a boat replacement if it will create a dual commercial/charter licensed operation.
- Fishing capacity is the number of persons permitted to fish from a vessel at any one time. Note that while NSW DPI acknowledges that the carrying capacity of a vessel may alter upon replacement, the fishing capacity remains the same as listed under your charter fishing business authority (fishing business card). Before a boat replacement can occur, your fishing capacity must be confirmed. If your capacity has not been confirmed, please contact the Charter Fishing Boat Licensing Section concerning requirements for confirming the fishing capacity of your vessel.

All information provided will be held by NSW DPI Fisheries of the NSW Department of Industry, Skills and Regional Development and will be managed in accordance with provisions under the *Privacy and Personal Information Protection Act 1998*.
