


NSW Dairy Environmental Guidelines

Understanding Patterns and Drivers of Rural Land Ownership

Research Project

There has been tremendous change in rural NSW over recent years. Researchers from the University of Sydney, with support from NSW DPI, are using spatial, quantitative and qualitative analysis techniques to investigate patterns of rural land ownership in relation to socio-economic and environmental processes. Key themes include drought, corporatisation of agriculture, farm aggregation, agricultural commodities, land fragmentation and land-use. AGRICULTURAL IMPACT STATEMENTS Large-Scale Solar Guidelines

The NSW Department of Planning & Environment released the <u>Large-Scale Solar Energy Guideline</u> in 2022. Appendix A of the guide provides information on the requirements for an Agricultural Impact Statement. Although this guide is specifically for larger scale development, it is also a useful resource from an agricultural impact perspective when assessing smaller scale developments.

Assessing a solar development? Consider whether there is opportunity for the co-location of the development with agriculture, e.g. sheep grazing or bee-keeping.
