Risks

Flood, Storm, Bushfire, Critical Infrastructure Failure, Pandemic, Earthquake, Biosecurity Emergency

Consequences · People/animal health and welfare impacts · Damage to pasture, equipment, infrastructure · No access to feed, water, staff, vets, trades, supplies, roads, processors, power

BEFORE AN EMERGENCY

PREPAREDNESS ACTIONS

- Prepare your farm emergency response and recovery plan. See links below
- ☐ Sign up to the hazard apps!
- ☐ Build your farm support network eg. other farmers, dairy service providers etc.
- ☐ Have a contact list of key people and what support they provide (eg. vet, agronomist, field officer etc.). Distribute to key team members.
- ☐ Implement impact mitigation measures/infrastructure at the farm, i.e. power back up/generator, hazard reduction around infrastructure, fuel and secure feed on hand
- ☐ Take pictures of everything in its original state (eg. for records and insurance claims)
- ☐ Identify a safe place for the dairy cows to reside during an emergency (and adapt depending on the situation)
- Determine how you will secure fodder and feed stock if they are confined for long periods
- ☐ Back up your data and a copy of important documents off site
- Discuss the emergency response plan with your team, so everyone is clear on what to do
- ☐ Stay aware of developing threats and potential impacts

DURING AN EMERGENCY

If you or others are in immediate danger CALL 000

RESPONSE ACTIONS

- ☐ Monitor disaster information sources (eg. weather forecasts, ABC radio, Emergency Alert text messages)
- ☐ Enact your emergency plan eg. relocate staff and livestock to a safe place and secure the premises where safe to do so
- ☐ Prioritise human safety first. Followed by protecting animal safety and infrastructure
- ☐ Follow safey warnings and instructions from emergency services
- ☐ Reach out to networks eg. service providers, farmers, family etc.

RECOVERY ACTIONS

AFTER AN EMERGENCY

Develop and implement your recovery plan which includes:

- Let NSW authorities and DA know the extent of your impact, so help can be provided
- ☐ Fill out NSW Government Disaster Survey (PiNDDA) for reporting farm impacts: www.dpi.nsw.gov.au emergencies/emergency/community/primaryindustries-naturaldisaster-damage-survey
- ☐ Enact plans to secure and feed stock, restore milking routine and manage any animal health impacts
- List who can help you with what and engage them early
- ☐ Capture the impacts (eg. photos and lists)
- ☐ Gather evidence of the impact and your corrective actions for insurance purposes
- ☐ Confirm what financial support is available and plan how you can access it eg. RAA, Rural Financial Counselling Service
- ☐ Reach out for help via DA, LLS, RAMHP, or Rural Aid and other support services (they are there to help across all levels of impact)


