#### Day 1: 24 October 2023 - Meeting opened 08:30am

#### 1. Member welcome, introductions, and housekeeping

The Chair welcomed Council members, NSW DPI staff, and the mentee. Aboriginal Commercial Fishers member acknowledged the traditional owners of the land.

#### 2. Review of agenda

The council accepted the agenda.

#### 3. Register of interests

The pecuniary interest register was updated prior to the meeting.

#### **ACTION:** Executive Officer to update pecuniary interests register and circulate.

#### 4. Confirmation of minutes from Meeting 26

The minutes for meeting 26 were accepted as a true and accurate record of the meeting.

#### 5. Actions from Meeting 26

The following actions have been completed and all others are in progress: 17.4, 18.7, 19.7, 19.9, 20.5, 20.9, 20.11, 22.12, 24.2, 25.7, 25.8, 26.1, 26.2, 26.3, 26.4, 26.5, 26.6, 26.7, 26.8, 26.9, 26.10, 26.12, 26.13, 26.14, 26.15.

#### 6. Correspondence

The following correspondence items were considered operational and were forwarded to NSW DPI to respond, topics included:

- Mud crab closure line on the Clarence River.
- Spanner Crab quota
- Pipi and Beachworm quota
- Wildcaught Coalition letter

A letter recommending that industry be notified at least six weeks prior to a CommFish NSW meeting being convened was tabled.

CommFish NSW considered the recommendation, noting in some instances council members do not receive confirmation 6 weeks prior to a meeting being coordinated.

# Action 27.1: DPI to publish meeting dates on the CommFish NSW web page as soon as practical once a date has been confirmed.

#### 7. MFAC member update

The MFAC member spoke of several key topics that he continues to pursue:

- Secure long term access to the resource.
- Access to market, including fish receiver.
- The cost of doing business, noting the increasing cost of freight and fuel.
- CommFish members were also informed that the Commercial and Recreational MFAC members are working together on a water quality project.

The Council discussed their support for the fish receiver fees to be reviewed and reflected as a transactional fee, similar to the logic applied to commercial fishing licences.

The committee further discussed their support for DPI to undertake a consultation process on the future of the registered fish receiver program, as it is a cost burden on small businesses including the fees (which are currently \$1,200 per annum for a commercial fisher and \$3,900 for a seafood business) to be reviewed and consider whether they should be reflected as a transactional fee.

RESOLUTION: CommFish support NSW DPI to undertake consultation on the fish receiver program.

#### 8. COMMFISH and RFNSW joint meeting

CommFish attended a joint meeting with the Recreational Fishing NSW Advisory Council (RFNSW) where they were provided with an update from the Director, Aboriginal Fishing & Marine Conservation, and a presentation from DCCEEW.

#### **Director, Aboriginal Fishing & Marine & Marine Conservation update**

Following is a summary of the update provided:

- Draft Network Management Plan (NMP) for NSW Mainland Marine Parks
   – the draft plans and associated submissions reports have been submitted by the Marine Estate Management Authority to the Minister for Agriculture and Minister for the Environment for consideration.
- Marine Park Advisory Committees the next meeting, the committee is scheduled for November 2023. The membership of four of the committees is due to expire in February 2024. A process will be undertaken to seek expressions of interest to fill the vacancies.
- Friends of Bongin Bongin Bay have submitted a proposal for a no-take aquatic reserve – DPI Fisheries will meet with the group to discuss their proposal. The department's current priority is effective management of the existing network of marine protected areas, particularly finalising and implementing the National Management Plans across the five mainland marine parks and progressing management rules review in line with the rules-related actions in the DNMP.
- Australian Marine Conservation Society (AMCS) Prof David Booth has authored a report on behalf of the AMCS, titled "Creating a World Class Marine Protected Areas system: Getting NSW Back on Track. A link to the report was circulated for the members information.
- Draft Aboriginal cultural fishing regulation It was noted the first draft regulation had been received, which was informed by the advice from the fisheries advisory council round table (held on 30 June) and the Aboriginal Fishing Advisory Council.
- Aboriginal Fishing Advisory Council (AFAC) an expression of interest process to fill four vacant regional member roles and to create a talent pool for future regional membership roles is underway from 01 November – 01 December. The next meeting of AFAC is scheduled for 14-15 November.

#### **DCCEEW presentation on Wind Farms**

DCCEEW delivered a presentation on the zoning process for offshore renewable energy and subsequent application process for wind farms. This provided council members raised the following keys issues during the presentation:

- The short timeframe allowed for the public to provide a submission.
- Concern over the impact of exclusion zones on fishing activity for both commercial and recreational fisheries.
- The impact that the wind farms will have on migratory species and the ecosystem.

DCCEEW indicated that the commercial fishing sector will be consulted as part of the feasibility stage once underway.

It was noted there was an opportunity to provide submissions on the Illawarra wind farm proposal.

#### 9. Fish Online Modernisation Program update

The committee was advised that the program build is going well and is currently targeting implementation on 1 July 2024.

The council discussed how it could provide further support to assist in removing any blocks to ensure the timeline is met. Council members are keen to see the delays in the rehosting of the suite of applications for FishOnline resolved. It is understood this will require Department of Planning and Environment to work proactively with NSW DPI Fisheries.

CommFish agreed that this is an important project that will improve efficiency for both industry and the Department. It is foreseen that the output of this program will generate many benefits for the management of the marine resource through improved information. This will benefit both the commercial sector and other marine resource stakeholders.

ACTION 27.2: The Chair to write to the DDG Fisheries indicating the councils support for the project and seek assistance to ensure there are minimal delays.

#### 10. Vessel Monitoring System (VMS)

The council noted an update from the Program Leader, Fisheries Innovation & Development, on the progress of the VMS project. The council was advised that the trials were progressing positively. It was also mentioned that NSW DPI are working with the Commonwealth to extend the period to roll out VMS on commercial vessels that are transiting through or operating within Commonwealth Marine reserves or Marine Parks.

#### **NOTED:** CommFish noted the progress.

#### 11. Commercial Fisheries Data Requirements

The Fisheries Innovation & Development Program Leader presented on the data collection requirements project. NSW Fisheries are reviewing the data limitations for fish stock assessment reports, Total Allowable Fishing Committee recommendations and harvest strategy development to improve the quality of the data captured. The review will also consider any changes that may impact on compliance.

CommFish members agreed on the importance of sound data for the improved management

#### **RESOLUTION:** Members reviewed and supported the proposed list tabled to the meeting.

#### 12. Resource Management update

An update on harvest strategies was provided. It was noted that the Line and Trap Harvest Strategy Working Group will be meeting in November followed by the Mulloway Harvest Strategy Working Group in December.

There was discussion on the pending transitional quota determinations that will be reviewed, for the first time since being set, by the Total Allowable Fishing Committee (TAFC) in 2024.

- It was noted that communication with industry is a priority, particularly in the lead up to the determinations. The council was informed a communique outlining the process, including engagement opportunities, will be distributed soon.
- It was identified that industry prefer advanced notice of any quota changes prior to the start of the new fishing season. It has been five years since the quotas were implemented and as per good business practices, fishers require time to review their business model, particularly should there be a change.

Council members were reminded of the opportunity for fishers to have input into the management of the fishery, through attending pre-stock assessment sessions (online) where scientists are seeking advice on factors that may affect catch trends, public submission periods and that fishers can attend the TAFC meetings.

RESOLUTION: CommFish supported the pending industry update to describe the process for setting the TAC for the transitional fishing determinations.

#### 13. Stay Afloat and Sea safe

Council was provided an update on the Stay Afloat and Sea safe programs.

#### 14. Program Leader, Commercial Fisheries update

The council were provided an update on general items by the Program Leader Commercial Fisheries.

#### Peak Body

The Government has made an election commitment to support the development of a peak body. A budget has been committed to underpin the commitment. An independent facilitator along with the working group, consisting of the Professional Fishers Association and the Wildcaught Coalition directors, are progressing the process to establish a peak body. The new peak body will not impact on the role or operation of Commfish

#### White spot

The process of coordinating Estuary Prawn Trawling Clarence River and Estuary General Prawn region 2 shareholders to temporarily stop fishing to receive an 'act of grace' payment has been completed. Correspondence presenting the opportunity for voluntary buy outs is immanent.

The process of demonstrating the Clarence River is white spot free is in progress, which is being led by the DPI Biosecurity team.

# NOTED: The Estuary Prawn Trawl CommFish member thanked the Minister and the Department for their support in the white spot response.

#### Southern Fish Trawl Working Group (SFTWG).

The SFTWG met on 23 October 2023 to provide advice on DPI proposed interim management arrangements for the fishery. The arrangement are to ensure whiting species stock is not adversely impacted by activated effort in the fishery as a result of the recent Commonwealth management changes to the Southern and Eastern Scalefish and Shark Fishery.

DPI proposed introducing a total catch trigger limit for whiting, which will result in a trip limit, to restrain the fishery's catch to historic harvest levels. With respect to depleted species, particularly Silver trevally and Grey morwong, DPI is coordinating a review and will set catch limits across all sectors. It also presents an opportunity to remind fishing business owners of the 2017 investment warning.

RESOLUTION: CommFish noted and supported the principles underpinning the direction for the proposed changes to the Southern Fish Trawl Fishery (recognising the details of the changes are still being developed).

#### CommFish expiring positions.

An expression of interest will be forthcoming for the positions that expire in January 2024.

**NOTED:** The chair thanked all members for their contributions and encouraged all members whose terms are expiring, to reapply. The chair strongly promoted council members to spread the word of the opportunity for other commercial fishers to nominate.

#### Northern Fish Trawl Cultural Development Workshop

The FRDC funded Northern Fish Trawl Culture project has been enlightening and provided an opportunity for both DPI and industry to build a better understanding of each other's processes and the barriers and opportunities for future collaboration. The last meeting was held on 4 October 2023.

#### **Lobster Working Group**

DPI is considering three minor changes as a result of outcomes from the Lobster Industry Working Group meetings. These items include removing the maximum allowable quota that can be leased by a fishing business, remove the requirement to carry a measuring device and efficiency gains in the use of lobster tags. DPI will work through the required processes.

RESOLUTION: CommFish noted and supported the proposed changes raised by the Lobster Industry Working Group.

#### Pipi management

DPI completed consultation with Pipi endorsement owners on future management arrangements, including an option to establish a relative biomass estimate. Feedback from those that responded indicated general support for a seasonal closure for region 4 during the spawning period. There was also support for closing the eastern end of Stockton Beach in recognition of the high level of recreational activity. There was mixed support for a daily/weekly bag limit within region 4. Further work is required with respect to any trip limits and the opportunity to develop a relative abundance index.

RESOLUTION: CommFish noted and supported the progress on implementing changes to the Pipi fishery for a seasonal closure in region 4, including ongoing work with the fishery on the other items raised.

#### **Boarding safety**

An action from the last meeting was raised. The item refers to the liability of fishing boat owners or skippers with respect to compliance officers being injured while boarding vessels. It was noted that DPI is responsible for the safety and associated liability for compliance officer through their work operations including boat boardings.

However, skippers and business owners are responsible for ensuring they are adhering to their safety management systems and NSW Safe Work rules. Importantly, the Australian Marine Safety Authority require compulsory reporting of any incident. It was noted that it is important that skippers are aware of their work health and safety obligations in general.

Members discussed boarding vessels without prior warning can startle fishers. It was suggested that a warning would be appropriate. It was suggested a startled person's response is unpredictable, and likely to negatively impact interactions.

ACTION 27.3: The Program Leader Commercial Fisheries to investigate options for a process for a working group from CommFish to engage with the DPI Compliance.

#### 15. Trust Ownership

The Estuary General (EG) Member tabled a paper on the options for ownership of shares and the limitations of using trusts to lead to more efficient fishing business management. The Fisheries Management 1994 s92 restricts the ownership of shares by a trust.

ACTION 27.4: NSW DPI to prepare feedback to CommFish with respect to section 92 and the use of trusts for fishing businesses.

#### 16. Management of Prawn Set Pocket Net Priority Determinations – Myall Lakes

CommFish considered options tabled by DPI, for potential consultation with prawn endorsed fishing business owners in region 4, with respect to the Myall Lake prawn draw. It was reiterated that the principle of access should remain proportional to the shares owned. The options were developed by DPI Fisheries in response to concerns raised by individual fishers and the Wildcaught Coalition on the Myall Lakes prawn set pocket net Priority determinations. CommFish provided the following feedback:

- There was support to seek feedback on reviewing the draw period.
- There was support to consult on amendments to the determination rules reduce the opportunity to transfers share for the draw period only.
- There was support to consider alternative fishing methods, however it was advised, given social license considerations, in addition as the area is a marine park, it not adversely impact the pocket set fishery, and hand haul nets are permitted for another sector, that consultation for additional methods is confined to hand hauling net only, with consideration to being able to use a crew without the additional shares for this method only.

# ACTION 27.5: CommFish supported the process tabled by DPI to pursue further consultation with prawn endorsed fishing business owners in region 4.

#### 17. General Business

#### **Abalone**

The NSW Abalone Association has drafted an Abalone Harvest Strategy and has provided the document to NSW DPI for review. The Program Leader Commercial Fishing commended the association for their forward thinking and advised that the document will be reviewed by NSW DPI, and used as a starting point for the harvest strategy process.

Raised a concern with the current marine heatwave and the effect it may have on the fish species, particular Abalone, which is relatively sedentary. The unknown impact is a concern.

#### **Update from the Inland Member**

The management of the fish kills in the Menindee Lakes was discussed and a desire for the inland fishery to pro-actively contribute where practical. DPI are reviewing options to support native fish, and reduce the risk of fish kills, through reducing European Carp biomass.

Action 27.6: DPI to keep CommFish and Inland member updated with DPI strategies with respect to managing European Carp in the Menindee Lakes system as appropriate.

Meeting closed at 4:45pm.
