

NSW Recreational Fishing Fee Exemption Certificate Application Form

Use this form to exempt your clients from having to individually pay the fee for recreational fishing. It is not compulsory to apply for an Exemption Certificate as it is ultimately your client's responsibility to be licensed unless they are otherwise exempt. Incomplete applications will encounter processing delays and may be refused.

NSW Recreational Fishing Fee Exemption Certificate Conditions

- Application for an exemption certificate is made to cover clients from having to pay the recreational fishing fee.
- Exemption Certificates do not authorise persons to operate boats without complying with NSW Maritime requirements.
- Application for an Exemption Certificate is Voluntary. There is no requirement for any person/business/partnership to hold one.
- Exemption Certificates are non-renewable. Once expired, holders may make another application for a further term at their discretion.
- Recreational fishing fee exemption certificates are non-transferable.
- Exemption Certificates may be amended or cancelled during their period of validity. A fee for amendment may apply.
- Exemption Certificates must be carried by the Certificate Holder at all times during fishing activities or Exemption Notifications displayed in a prominent visible place for inspection as required by NSW DPI staff.


