The NSW Department of Primary Industries (DPI) Native Game Bird Management Program allows licensed hunters to help landholders manage the impacts of native game birds on their agricultural crops.

This Hunter Kit will help you meet your obligations under the program and to harvest native game birds legally, ethically and humanely.

Before you hunt native game birds (ducks) on a licensed property you must use your Native Game Bird Hunter Diary (physical or digital) to record the total licence allocation for each Native Game Bird Management (Owner/ Occupier) Licence.

Each time you leave a property, you must record the number of game ducks harvested, even if you will continue to hunt later. When you have finished hunting, you must report your total harvests to NSW DPI.

# Licensing and regulation

The NSW Native Game Bird Management Program is legislated under the *Game and Feral Animal Control Act 2002* and the *Game and Feral Animal Control Regulation 2022*.

To participate in the NSW Native Game Bird Management Program, you must:

- pass the Waterfowl Identification Test (WIT)
- hold a current NSW General or Restricted Game Hunting Licence that is updated for game birds ('GB' must be printed in the special conditions section on your licence card)
- have permission to hunt from a landowner or manager who holds a current Native Game Bird Management (Owner/Occupier) Licence that covers the properties you will hunt
- comply with the special native game bird game hunting licence conditions in addition to the game hunting licence conditions
- comply with the mandatory NSW Game Hunting Licence Code of Practice.

Licence and special conditions are sent to you with your licence card. You can also view all the conditions, rules for the Program and the Code of Practice by visiting **[www.dpi.nsw.gov.au/hunting](http://www.dpi.nsw.gov.au/hunting)**.

# Native game bird species

The following species can be hunted under the NSW Native Game Bird Management Program, if there is a current State-wide quota for that species and a total licence allocation is available.

- Australian Shelduck or Mountain Duck (*Tadorna tadornoides*)
- Australian Wood Duck or Maned Duck (*Chenonetta jubata*)
- Black Duck or Pacific Black Duck (*Anas superciliosa*)
- Blue-winged Shoveler or Australasian Shoveler (*Anas rhynchos*)
- Chestnut Teal (*Anas castanea*)
- Grass Whistling Duck or Plumed Whistling Duck (*Dendrocygna eytoni*)
- Grey Teal (*Anas gracilis*)
- Hardhead Duck or White-eyed Duck (*Aythya australis*)
- Pink-eared Duck (*Malacorhynchus membranaceus*)
- Water Whistling Duck, Wandering Whistling Duck or Whistling or Wandering Tree Duck (*Dendrocygna arcuata*)

*Always positively identify your target species – if you are not sure, don't shoot!*

## Permission to hunt

You must have the landholder's permission to hunt on their property. Having permission before you enter a property is one of the principles in the **NSW Game Hunting Licence Code of Practice**. Complying with the code of practice is a mandatory condition of your licence.

When you receive permission to hunt, you must ask for the landholder's Native Game Bird Management (Owner/Occupier) Licence number so you can find out the total allocations attached to that licence and record these in your Hunter Diary.

# Contacting a landholder

As a government agency, **DPI cannot facilitate hunting opportunities**. It is your responsibility to approach landholders who hold a Native Game Bird Management Licence and ask for permission to hunt on their land.

Landholders who need hunters have the option of going on the **Landholder Register**. You can access the register from the Native Game Bird Portal using your licence number and security PIN.

You can place yourself on the **Hunter Register**, which means your details and availability can be accessed by licensed landholders who may require assistance. Access the online Hunter Register form through the Native Game Bird Portal.

*DPI will not provide the contact information of any landholders not listed on the Landholder Register.*

# The Native Game Bird Management Licence

Landholders can apply for a Native Game Bird Management (Owner/ Occupier) Licence for sustainable agricultural management purposes only. This means a licence can only be issued where native game birds are impacting agricultural crops on private agricultural lands.

## State quota

Each year, a State-wide quota is set by DPI Hunting. The State quota is based on the best available scientific information on the estimated populations of native game birds across NSW.

## Licence species allocations

When a landholder applies for a Native Game Bird Management (Owner/ Occupier) Licence, their property/s are assessed for a total licence allocation against the impacts reported on their application and the State-wide quota.

Total licence allocations cover **all properties** listed under the landholder's Native Game Bird Management (Owner/Occupier) Licence. The number and species of game ducks harvested under each licence is tracked against the approved State-wide quota for each species, which must not be exceeded.

You are only able to hunt native game bird species that are included in the total licence allocation.

*DPI Hunting monitors licence allocations and hunter harvest reports on behalf of the landholder. It's important to submit your harvest returns within 48 hours from the completion of your hunt, so the most accurate total allocation is available to the next hunter.*

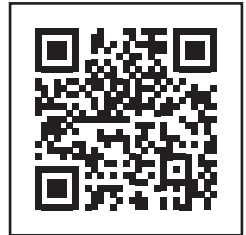
## Using your Native Game Bird Hunter Diary

### Before you hunt

You must obtain and record the number and type of native game birds remaining for the Native Game Bird Management (Owner/Occupier) Licence total allocation, in the Native Game Bird Hunter Diary supplied by the Regulatory Authority **no more than 48 hours before commencing your hunt.**

*You can use either a physical or digital Native Game Bird Hunter Diary*

### How to look up the total licence allocation

1. Login to online licence holder services using your game hunting licence number and security PIN.
2. Select the native game bird portal.
3. Enter the landholder's Native Game Bird Management (Owner/Occupier) Licence number to see the total available licence allocation.

## When you leave a property

Each time you leave a property, even if you will continue hunting on the same trip, you must **record the total number and type of native game birds harvested** in your Native Game Bird Hunter Diary.

This means you must have one diary page for each property you hunt.

If the properties are under the same Native Game Bird Management (Owner/ Occupier) Licence, you may continue to use the total licence allocation numbers you recorded before beginning to hunt.

## After you hunt

When you have finished hunting, you must lodge a Native Game Bird Harvest Return with the Regulatory Authority, recording the total number and type of native game birds harvested under the Native Game Bird Management (Owner/Occupier) Licence, **within 48 hours of completion of your hunt**.

If you did not hunt or were not successful, you do not need to submit a nil return.

## How to lodge your native game bird harvest return

1. Login to online licence holder services using your game hunting licence number and security PIN.
2. Select the native game bird portal.
3. Enter the landholder's Native Game Bird Management (Owner/ Occupier) Licence number.
4. Select 'Return', next to the total allocation information.
5. Enter the date started, date finished and the number of game birds harvested across all properties you hunted.
6. Submit your return and note your native game bird harvest reference number.

# Manage your hunt

## Your hunting area

A Native Game Bird Management (Owner/Occupier) Licence covers the whole of each listed property. You should clarify the properties listed under their licence and obtain each property's boundary information before you commence hunting.

Only hunt in areas specified by the landholder.

If two properties are covered by a Native Game Bird Management (Owner/Occupier) Licence and they are divided by a waterway, you may hunt on that waterway provided:

- the waterway is privately owned, not public land, and within a property boundary
- both properties are covered by a Native Game Bird Management (Owner/Occupier) Licence
- you have permission from each landholder to hunt on both properties.

## Shot type

Hunters are encouraged to use non-toxic shot when hunting native game birds in NSW.

## Utilisation of native game birds

DPI encourages the utilisation of native game birds harvested under the program. All reasonable effort should be made to retrieve downed birds including removing bird carcasses from any crop, dam or waterway.

## Hunting native game birds at night

Under the Game and Feral Animal Control Regulation 2022, you must not hunt a native game bird at night unless:

- a. you are using lighting of sufficient brightness to enable you to clearly see and identify the species of native game birds being hunted, and
- b. the native game birds are in the immediate vicinity of, or are reasonably likely to adversely impact, a planted crop.



## Tips for hunting safely at night

- Notify the landholder of your intention to spotlight game birds at night.
- Know the hunting environment extremely well. During daylight hours, familiarise yourself with the hunting area before you begin to spotlight.
- The shooter must always be in front of the spotlight operator.
- Spotlights and gun-mounted lights must be of sufficient brightness to enable you to positively identify the species of native game bird - do not shoot if you are unsure.
- Always have a safe backstop; do not shoot over a crest or hill.
- Be extremely careful of ricochet when shooting over water.
- Only spotlight in a small group and maintain a safe shooting zone.
- Always unload your firearm and ensure it is safe before collecting any harvested birds.
- Avoid using untrained gun dogs at night – they can be a distraction to yourself and others.
- Pay particular attention when shooting close to fences, boundaries, roads and tracks.

## Decoys and callers

Use of decoys and callers is permitted and encouraged under the Native Game Bird Management Program.

Correct use of game bird decoys and callers encourage game birds into a more effective range so you may target them humanely.

Decoys should also be used as markers to reference your personal maximum shooting skill range.

*Decoys can help you to identify downed bird fall areas and individual decoys may assist in pinpointing exact locations.*

## Retrieval strategy

Plan your retrieval strategy before you start hunting. You must make every effort to retrieve downed game birds you have shot and to ensure retrieval is done efficiently and humanely.

When planning your hunt, consider the following:

- identify hunting areas or shooting zones where downed birds can be readily retrieved
- don't assume that downed birds have been killed outright
- once a bird is struck, stop shooting and retrieve it
- work with another hunter, if possible, to assist in retrieval of downed game
- use equipment that aids retrieval of downed birds, such as gun dogs and swatter loads.

All reasonable effort should be made to retrieve downed birds.

## Using a gun dog or retriever

A well-trained retriever can significantly increase the chance of recovering downed birds.

Hunters must ensure that the landholder has approved the use of dogs on each property.

There are many hunting organisations and kennel clubs that have programs specifically for training working gun dogs. You must ensure any animal assisting you is tightly controlled and that their use does not contravene the *Prevention of Cruelty to Animals Act 1979*.

## Respectful hunting

Think of yourself as a guest on each property and observe the hunting conditions the landholder sets for you.

*Respect all properties that you hunt by leaving gates as you find them, picking up your spent shotgun cartridges and taking home your rubbish.*

# Don't wing it campaign
