1. Member Welcome, Introductions and Housekeeping

Meeting opened 08:45am

NOTED:

- The Chair welcomed Council members and NSW DPI staff.
- The traditional owners of the land, past, present, and emerging were acknowledged.

2. Review of Agenda

NOTED:

Council accepted the agenda.

3. Review, Declarations and update Register of Interests

NOTED:

It was noted the SUTS Member provided an update to the pecuniary interest record, prior to the

meeting. The register will be circulated to members.

ACTION: Executive Officer to update pecuniary interests register and circulate (permanent action).

4. Confirmation of Minutes from Meeting 22

NOTED:

The committee discussed the general business item "BEP item considered" from meeting 22. The Chair sought feedback on the general business item with the majority of members present agreeing the minutes required no change. The minutes for meeting 22 were accepted as a true and accurate record of the meeting.

5. Current actions arising from Meeting 22

NOTED:

- The following actions have been completed: 20.5, 20.6, 20.7, 21.1, 21.2, 22.3 and 22.10.
- All other actions are in progress.

6. Correspondence received

NOTED:

One letter was received outside the timeframe for this meeting. The Chair directed the correspondence to be sent to DPI for consideration ,on the basis it referred to an operational issue.

7. Meeting with Minister

The opportunity to meet with the Minister in the morning prior to the meeting was welcomed by those in attendance. There was positive discussion on key issues such as the driving changes through the Business Efficiency program, supporting consultation on a review of the Fish Receiver program, and importance of long-term access security for industry to improve investment and participant's wellbeing.

All topics discussed aimed to provide insight into the support needed for the commercial fishing industry to move forward on improving, investment, growth, productivity, and welfare.

8. Framework for Aboriginal cultural fishing in harvest strategies

lan Knuckey (Fishwell Consultancy) provided a presentation on a project to develop a framework for Aboriginal cultural fishing harvest strategies and the processes to integrate them with other harvest strategies being developed.

ACTION 23.1: Executive officer to share CommFish member contact details with Fishwell Consultancy.

9. Update from the Program Leader Commercial Fisheries (PLCF)

Harvest Strategies

The Spanner crab Harvest Strategy Working group have supported the concept to develop a co-

management approach to managing seasonal closures. The Program Leader Resource Management has been engaged to provide harvest strategy working group progress updates at future CommFish meetings.

Spanish mackerel

Queensland are reviewing their Spanish Mackerel management strategies and are currently consulting on proposed new arrangements.

Vessel Monitoring System (VMS)

The Program Leader for Innovation and Development has advised that NSW DPI has been successful in securing the VMS grant from the Commonwealth for the project, noting the Commonwealth's Marine Park regulatory amendments have not been amended.

Woolworths

Woolworths are currently not sourcing fresh prawn product from NSW. DPI are in discussion with relevant stakeholders, relating to the third-party certification of fisheries.

10. Development of a Commercial Fishing Strategy

The Hon. Dugald Saunders MP, Minister for Agriculture, wishes to engage CommFish NSW to develop a Commercial Fishing Strategy (the Strategy) for NSW and for CommFish to facilitate broader industry input and consultation on the draft strategy.

The overall aim of the proposed Strategy is to provide a strategic roadmap for the industry to drive productivity, reduce regulatory burden, promote innovation, improve community support and strengthen the industry as a whole.

NOTED:

- CommFish members are provided an opportunity to provide input.
- the broader industry feedback will be sought on the draft document.
- members advised it is important that the BEP is finalised.

ACTION 23.2: All members to provide feedback via the executive officer, who will coordinate a draft with the Chair.

11. Update from the Deputy Director General Fisheries

The Deputy Director General provided a general update on the proposed rolling out of the pending nine BEP changes, including the new management fee changes.

Provided context to the development of the Commercial Fisheries strategic plan.

12. General Business

12.1. Increase in Drumlines

With the increase in drumlines many are interested in knowing the number of sharks and other species that have been caught, if it is publicly available. It was also mentioned that the ability for boats to get a notification when a tagged shark is in the vicinity would assist in safe work protection.

ACTION 23.3: Program Leader Commercial Fisheries to investigate whether the capture statistics from the drumline program are publicly available.

12.2. Licensed Fishing Boats (LFB's)

Discussion was had on the removal of LFB's. Members were advised no fixed date had been set, however the department was working towards implementation early in the next financial year. There were concerns by several Members that those purchasing a LFB within this period may not be aware of the proposed removal or it could hinder others from increasing their business within this timeframe due to the cost to purchase now knowing that they will be removed soon. The committee were advised that business services were notifying persons who were trading boat licences of the pending change through the application process.

12.3. Setting of quota

A concern was raised that quotas were not set at the right level in some fisheries. Whilst the foundation of setting quota is based primarily on the science, it was noted that the Total Allowable Fishing Committee also take other factors into account, such as natural disasters, markets, and other factors that could influence effort in the fishery.

It was also reaffirmed that harvest strategies for key species will assist with quota setting in the future.
