Day 1 16 February 2022

1. Member Welcome, Introductions and Housekeeping

Meeting opened 08:30

NOTED:

- The Chair welcomed Council members and NSW DPI staff.
- The traditional owners of the land, past, present, and emerging were acknowledged.

2. Review of Agenda

NOTED:

Council accepted the agenda.

3. Review, Declarations and update Register of Interests

NOTED:

Members confirmed that they have reviewed and updated their pecuniary interest register information, prior to the meeting. An updated register will be circulated to members.

ACTION: EO to update pecuniary interests register and circulate (permanent action)

4. Confirmation of Minutes from Meeting 21

NOTED:

The minutes for meeting 21 were accepted as a true and accurate record of the meeting.

5. Current actions arising from Meeting 21

NOTED:

- The following actions have been dealt with 8.19, 19.12, 21.1, 21.4 21.7 and 21.8.
- All other actions are in progress.

6. Correspondence received

NOTED:

Several pieces of correspondence were received outside the timeframe for this meeting. The Chair directed two be sent to members out of session for information and the other to DPI for consideration on the basis it was operational. The correspondence related to:

- Moruya River and Wapengo Lake closures
- Operation of CommFish
- Lobster Harvest Strategy

7. Business Efficiency Program

NOTED:

BEP proposals concerning the temporal controls applying to the harvest of Spanner Crab will be addressed by the Spanner Crab Harvest Strategy Working Group.

The below papers were presented to CommFish for consideration. A summary of key issued noted and recommendations to the Minister are provided in Appendices B – E

- Lobster Fishery
- Further EG Fishery spatial and temporal controls, plus supplementary paper
- Further species restrictions

Further proposals that may be out of scope.

8. NSW Commercial Fisheries Economic and Social Indicators 2019/20 results

Anders Magnussan, BDO EconSearch, provided a presentation of the commercial fisheries' economic and social report for 2019/20.

Members were presented with the outcomes of the report and provided an opportunity to provide feedback and ask questions, which occurred.

NOTED:

- The estimates of state gross value of product are determined at the first point of sale.
- The reports provide a benchmark for future comparisons and will be improved over time as more fishers participate in the surveys and catch and effort data improves.
- Some CommFish members that participated in the survey spent considerable time helping the interviewers and that this should help with future surveys and survey results.

9. Modernising Commercial Fisheries Systems (Digital Restart Fund update)

DPI (Brett Fifield and Jenianne Hall) gave a presentation on the progress of the Digital Restart Fund project to modernise FishOnline and supporting systems.

NOTED:

DPI explained the steps taken so far, including to better understand fishers' experiences with FisherMobile and to work out ways to make it easier for fishers to use. These steps included

- (a) engagement with fishers to understand their needs and challenges, and
- (b) testing of changes to improver fishers' experience.

Key issues noted were:

- pre-filling fields is a focus of the project to make using the system easier for fishers, but that this would require all fishers using it to log-on a fishing event before they go fishing.
- connectivity when at sea and out-of-range will be addressed by caching data. This will enable fishers to use the system anywhere and when a fisher is within range of a network the data will automatically upload.
- it would be beneficial for DPI to check-out the Commonwealth's electronic reporting system because it is tried and tested and good to use the Southern Fish Trawl member invited the project team to see his system onboard his boat.
- industry consultation will be required before changes are implemented and the project team will give CommFish further updates as the project progresses.

ACTION 22.1: EO to provide member contact details to the digital restart team so that the team may arrange to check-out the Commonwealth's electronic reporting system and to contact any member of CommFish should expert industry advice be required.

10. RFNSW proposal to review recreational management of Snapper & Kingfish

NOTED:

- RFNSW are considering options to improve recreational fishing experiences for those recreationally targeting Snapper and Kingfish.
- The options under consideration are not being proposed for the commercial industry.
- Both species are classified sustainable.
- A proactive approach to recreational take is important given that the NSW population is increasing and observations that externalities such as COVID-19 can drive sometimes significant (and in some cases short term) increases in recreational fishing pressure.
- Harvest Strategies for Snapper and Kingfish are proposed to the developed which will use the best science available and this will require commercial industry involvement.

11. General Business

Confidentiality:

A concern was raised that comments by a member during a joint advisory council meeting with RFNSW have been taken out of context and included in a recreational fishing publication. DPI confirmed that the issue has been referred to the Chair of RFNSW.

Crowdy Head mullet season:

Crowdy Head fishers seek a permit to access waters on the southern side of Crowdy Head pending finalisation of a BEP proposal relating to these waters on the basis the beach on the norther side has been washed away and the mullet season is about to start.

ACTION 22.2: DPI to consider the request, subject to any directions given by the Minister.

BEP items considered

It was raised that an item previously considered and not supported was not clearly articulated at the time a decision was made. Given the high volume of items considered by CommFish it will continue to progress the supported proposals, recognising that the current program is unlikely to be the only opportunity for future business efficiency improvements.

Boat licensing changes - Hawkesbury EPTF

Members discussed that some Hawkesbury EPT fishers are concerned with the decision to implement a new maximum boat length of 16 m for the EPT Fishery. It was noted:

- there are multiple views.
- the fishery operates on the doorstep of the most heavily populated region in NSW.
- relevant considerations include ability to cost effectively replace boats, boats suitable for the waters concerned, opportunity for onboard processing to add value, likelihood of additional *large* boats, safety, and the industry's social licence.

ACTION 22.3: DPI to consider the concerns of Hawkesbury EPT fishers, subject to any directions given by the Minister.

12. Update from the Deputy Director General Fisheries

New Minister

The Hon. Dugald Saunders has been appointed as the new Minister for Agriculture and Minister for Western New South Wales.

Business Efficiency Program

DPI NSW are working to implement the first batch of BEP proposal on the 1st of July 2022 noting that there are factors outside of DPI's control that could impact delivery by this date.

Harvest Strategies

- The Trawl Whiting Harvest Strategy was adopted and used by the Total Allowable Fishing Committee to set the TAC for the upcoming season.
- Harvest strategies are in the process of being developed for Spanner Crab and Mulloway.
- Upcoming harvest strategies include Abalone and key inshore ocean species that may be
 of interest to OTL fishers.

Peak Body

Work continues with industry representative bodies (PFA and WCFC) and an independent facilitator to progress the establishment of a peak body. The peak body would serve a different role to CommFish. DPI supports and appreciates the hard work that CommFish has been doing.

Woolworths

DPI is working with Woolworths to support the ongoing the stocking and sale of School Prawn and Eastern King Prawn into the supermarket.

Southern Fish Trawl (SFT) transitions

DPI is working on the proposal to transition the NSW SFT Fishery to control.

Eat more seafood

Further "eat more seafood" grants have been allocated. A marketing strategist has been engaged to investigate NSW species to promote and species that could be better utilised.

National Fisheries Plan

A National Fisheries Plan will be released soon by the Commonwealth government.

13. Meeting Closed

Closed at 4:45pm.

Day 2 17 February 2022 meeting continued

Opened at 08:00am.

14. Recreational Fishing Environmental Assessment (EA) update

CommFish were given an update on Environmental Assessment of recreational fishing in NSW.

NOTED:

The project aims to deliver:

- Environmental Assessment (EA) covering environmental, social, economic and cultural issues for saltwater and freshwater fishing.
- A Recreational Fishing Management Strategy (RFMS) that includes goals, objectives, risk mitigation measures and a monitoring program.

ACTION 22.4: DPI to provide further updates, including before the EA and RFMS are finalised.

15. Aboriginal Cultural Fishing Local Management Plan (LMP)

CommFish were given a presentation on a proposed pilot cultural fishing management plan for the Hastings region.

NOTED:

- DPI has partnered with the Hastings and Tweed coastal Aboriginal communities to draft a pilot cultural fishing management plan for these areas.
- The local management plans will give structure to the approach to cultural fishing in relation to the waters that may be fished under the plan, the sue of fishing gear, take and possession limits for culturally significant species, and ongoing involvement of local Aboriginal communities.
- CommFish congratulated DPI and the local Aboriginal community on their constructive engagement and development of an agreed approach to cultural fishing and appreciated the presentation.

ACTION 22.5: DPI to provide further updates, including before each plan is finalised.

16. Fisheries regulation amendments – (compliance and enforcement)

CommFish were given an update on a proposed batch of fisheries regulation amendments focussing on enforcement and related matters, including new penalty infringement notice amounts (fines) and fit and proper person tests for commercial fishers.

NOTED:

- the fit and proper person test will initially only apply to new entrants
- fines are one way to influence fisher behaviour, including for the benefit of fisheries resources and the stakeholders who enjoy or rely on them
- additional species are to become indictable species
- stronger enforcement powers are important to deter illegal activity and to help protect the future of the NSW commercial industry
- enforcement options include cautions, fines, and prosecution and various requirements apply to the exercise of these powers including, for example, obligation to take into account the seriousness of an offence and mittigating factors
- under current law, it is not an offence to purchase fish from someone who is not a licensed commercial fisher

RECOMMENDATION:

CommFish recommends the following:

- increase the fine for interfering with set fishing gear (e.g. \$5,000),
- increase the fine for possessing crustaceans with ova or with ova removed (e.g. \$1,000),
- all species subject to commercial quota are declared 'indictable species', and
- the penalty notice amount for quota reporting is not increased until FishOnline is

upgraded and is more stable and reliable.

The first three recommendations are made to further deter ongoing unlawful activity known to be taking place and because the fines proposed are unlikely to deter such activity.

ACTION 22.6: Chair to write to the Director of Compliance with the advice (recommendations) of the Council.

17. General update from the Director of Compliance and discussion

NOTED:

The following were noted, some of which were in response to issues raised by members.

- It was noted that a decision to not issue a commercial fishing licences to a person because the person is not fit to hold a licence may be appealed to the National Civil and Administrative Tribunal (NCAT), and that DPI proposes to consider the tests or principles applied by the NCAT when making such decisions.
- In response to concern from members over the low penalties for fisheries offences issued by some courts, DPI advised that it is investigating options that involve engaging courts (or magistrates) to improve their awareness of the importance of fisheries laws and the severity of relevant offences.
- Members highlighted a potential emerging fisheries compliance issue involving the online marketing of illegally harvested seafood and associated implications including:
 - o non-reporting of catches, tax avoidance, non-compliance with health and safety requirements, and potential biosecurity and health risks,
 - lower prices for seafood and the impact this will have on legitimate commercial fishers and markets, and
 - the overall negative impacts this could present for the profitability and metal health of those in the commercial fishing industry.

ACTION 22.7: Chair to include in the letter above (refer previous action) council's gratitude for the recent recruitment of additional Fisheries Officers and the need for more along with the emerging fisheries compliance issue identified by members.
