Hemp Industry Instrument of Delegation (Secretary) 2024

I, Rebecca Fox, Secretary of the Department of Regional NSW, make this Instrument of Delegation under section 47 of the *Hemp Industry Act 2008* (the Act).

1 Delegation of functions

The functions under the Act specified in Column 1 of Schedule 1 are delegated to any person in the delegate category specified in Column 2 of Schedule 1.

2 Interpretation

(1) In this Instrument

administrative and clerical officer grade 9 or above means a person employed by the Department as an Administrative and Clerical Officer at grade 9 or above in accordance with the Crown Employees (Administrative and Clerical Officers – Salaries) Award 2007, and whose responsibilities relate to the administration or execution of the Act.

authorised officer means a person appointed under section 18 of the Act.

delegate category means the categories described in Column 1 of Schedule 2.

food safety officer grade 5 or above means a person employed by the Department as a food safety officer at a grade 5 or above in accordance with the Crown Employees (Department of Regional NSW) Food Safety Officers Award.

person in the delegate category means any person who is for the time being assigned to a role, or performing the duties and responsibilities of a role, specified in Column 2 of Schedule 2 in respect of each delegate category.

the Regulation means the Hemp Industry Regulation 2016.

role includes office, and a person **assigned** to a role includes the **holder** of an office.

Senior Executive Band 1 means a Senior Executive employed by the Department in Band 1 under the *Government Sector Employment Act 2013* or an employee with an equivalent salary level, and whose responsibilities relate to the administration or execution of the Act.

Senior Executive Band 2 means a Senior Executive employed by the Department in Band 2 under the *Government Sector Employment Act 2013* or an employee with an equivalent salary level, and whose responsibilities relate to the administration or execution of the Act.

Senior Executive Band 3 means a Senior Executive employed by the Department in Band 2 under the *Government Sector Employment Act 2013* or an employee with an equivalent salary level, and who responsibilities relate to the administration or execution of the Act.

- (2) Words and expressions that are defined in the Regulation the same meaning in this instrument.
- (3) Unless otherwise specified, references to a role are references to a role within the Department.
- (4) The summary of a function in Column 3 of Schedule 1 is for general explanation and does not limit the delegation of functions under the provisions identified in Schedule 1.

3 Commencement

This Instrument commences on the day on which it is signed.

4 Revocation

The Hemp Industry Instrument of Delegation 2021 published in the NSW Government Gazette No. 585 of 12 November 2021 is revoked, as in any instrument revived as a result of this revocation.
