1. Introduction by the Chair

The Chair welcomed members to the twelfth meeting in Sydney. During his remarks, the Chair thanked members for their inputs and contributions to RFNSW, and to decision making in recreational fishing since the first meeting. The Chair noted that the Department would be advertising an expression of interest soon for membership on the Council and encouraged members to reapply for another three-year term.

2. Register of Interests

The Chair requested that members declare any changes or additions to the Register that have arisen since the last meeting. The following additional interests were declared:

David Rae advised that he is no longer a student at Southern Cross University.

Stan Konstantaras advised that he was a member on the National Recreational Fishing Council and that his involvement with the Recreational Fishing Alliance in the DPI tender process entitled: 'Delivery of sector representation, consultation and communication services to the recreational fishing sector' had finished, given the completion of the tender process.

It was determined there were no conflicts of interest associated with the above activities.

3. Agreement on the agenda

RFNSW members agreed on the agenda for the meeting.

4. Adoption of the record of the previous meeting

The draft outcomes of Meeting 11 were accepted without change as a true and accurate record of that meeting.

5. Proposed future meeting schedule

To be confirmed following the expression of interest process for RFNSW membership.

6. Review of achievements and action items from previous meetings

Council noted the status of achievements and action items from the previous meeting.

Action item: DPI to investigate the production of an RFNSW Annual report for 2018/19.

7. a. Progressing the top 10 priority issues: reviewing status

Council members have identified details of key issues in their regions, sectors or fields which have been collated into an issues summary document. A 'live' structured RFNSW work plan with specific actions and responsibilities is being maintained. The status of the various actions was discussed and further actions developed where required.

7. b. Top 10 issue: Stock assessment of key recreational fishing species

DPI updated the Council on the national 'Status of Australian Fish Stocks' (SAFs) reports for yellowtail kingfish and snapper, which are due to be released in March 2019. It was noted that the current assessment highlights that the biomass of the part of the kingfish stock that occurs in NSW waters is likely to be depleted and that recruitment is likely to be impaired. Current fishing mortality levels are expected to prevent the NSW part of the stock recovering from a recruitment impaired state. The NSW component of the snapper east coast stock appears to be fishing on a sustainable basis.

Action item: DPI to circulate the Status of Australian Fish Stocks report to Council members when published.

Action item: The Chair to write to the Minister and advise him about the SAFs report and the concern regarding the NSW stock of Kingfish. RFNSW recommended that DPI be requested to provide an urgent response, including appropriate management actions to rebuild the stock of this important recreational and commercial fish species (noting RFNSW established its position on required management arrangements previously). The Council requested that the Minister be asked to provide a timeline for the response.

Action item: The Chair to write to CommFish providing the SAFs paper (when published), which provides scientific evidence to justify urgent management action to address the overfished status of kingfish. The letter should outline key findings of the SAFs report and request commercial fishing industry support for introducing management changes in line with changes proposed for the recreational fishing sector so that both sectors can work together to restore this shared stock.

Recommendation: RFNSW recommended that more scientific monitoring and research be undertaken on Snapper to better inform the current stock assessment. This could include additional monitoring through the Research Angler Program and modelling different management scenarios to create a better recreational fishery for the species.

7. c. Top 10 issue: Mulloway recovery plan

An update on use of Research Angler Program data in the DPI report titled 'Monitoring and assessment of the impact of management changes under the Mulloway recovery program' was provided at the meeting.

Council members were updated by DPI on Roads and Maritime Services offsets associated with the Batemans Bay bridge replacement project.

Action item: The Chair to write to the Minister regarding the need to explore legislative change to incorporate specific and direct recreational fishing offsets into development and planning processes where a development or planning process negatively impacts on recreational fishing. This should be in addition to routine habitat offsets. These offsets could include artificial reefs, fish stocking etc.

7. d. Top 10 issue: Strengthening social licence for recreational fishing in NSW

DPI advised that the Fish for Life user guidelines have been finalised and will be uploaded to the DPI website. DPI is developing a procurement strategy for the tender process to appoint a marketing company to launch Fish for Life, and to develop campaigns aimed at improving the social licence for the recreational fishing sector in NSW.

Action item: DPI to update the Department's website to provide information on Fish for Life and how fishing clubs, fishing organisations etc. can access and use the Fish for Life logo.

Action item: Jo Starling to provide text for an article on the Fish for Life campaign in the next edition of Newscast.

Action item: DPI to seek feedback from RFSTEC and RFFTEC regarding placement of the Fish for Life logo on the Recreational Fishing Trust Infrastructure plaques.

7 e. Top 10 issue: Hawkesbury Shelf marine bioregion

DPI advised that information on recreational fishing was one of many datasets analysed during the overall Hawkesbury Shelf Marine Bioregion assessment project. Recreational fishing information was included to avoid selecting key recreational fishing sites. RFNSW was also advised that implementation of Stage 1 of the ten-year state wide Marine Estate Management was progressing with actions under the nine initiatives to address priority threats.

7 f. Macquarie River Orange Pipeline and Burrendong Dam

DPI provided an update on the fish-associated impacts of the Macquarie River Orange pipeline and advised that the pre-pipeline operational sampling of the fish community in the river has been completed. The research team is currently conducting post-pipeline operational sampling of the fish community, with the next sampling event scheduled for March 2019. At this stage, it is too early for any conclusive results.

Part of the second component of the sampling aimed at examining efficiency of the screens has been conducted at Narrandera. This sampling compares the effects of replicas of the existing screen to different sized mesh screens on various species of native fish.

There has been little extractive use of the pipeline in 2018. However, this spring/summer has seen the triggers reached resulting in a total of approximately 183Ml extracted during September-November 2018.

DPI also advised that there have been delays experienced with the Burrendong Dam Safety Upgrade project due to the fishway optimisation assessment that is just commencing. Information from this assessment will be available in nine months time, which will guide future funding bids and selection of achievable on-ground activities. WaterNSW are aware of their obligations as part of the Dam Safety Upgrade, and are intending to complete works once future outcomes are known.

8. Inland fish kills including at Menindee Lakes

DPI in collaboration with WaterNSW have been investigating a number of fish kills, including in the Darling River at Menindee, in the Namoi River below Keepit Dam, the Lachlan River at Wyangala Dam and also in Lake Hume. Council members discussed the various contributing factors, including drought, excessive heat, algal blooms, black water events, resource sharing policies and climate change. It was acknowledged that these issues are likely to continue to compound, causing future fish kills.

It was acknowledged that there are a wide range of programs and initiatives aimed at achieving better native fish outcomes. These include better targeted environmental flows, fish passage works and measures, increasing hatchery capacity, the National Carp Control Plan, riparian land management initiatives and the 'Screens for Streams' initiative. However, it was also recognised that we need to escalate a number of these initiatives in order to build the necessary resilience across our fish populations to adapt to the effects of climate change.

Whilst many of the initiatives identified above are integral parts of existing State and Commonwealth programs, the 'Screens for Streams' initiative is seen as lagging considerably behind, despite robust scientific backing and strong support from recreational fishers. It was acknowledged that funding of \$500,000 over five years had been supported from the Recreational Fishing Trusts for the 'Screens for Streams' project, which further highlights the high priority nature of this issue.

Action item: RFNSW highlighted the issue of lack of screens on water extraction pumps throughout the Murray Darling system which is considered to have major impacts on native fish populations. The Chair to write to the Minister to request that a planning workshop/forum be facilitated with participation from Water NSW, DPI, relevant water management experts, key industry stakeholders and recreational fishing stakeholders (via RFNSW members) to bring together the current body of knowledge on fish screening across the Science, Policy and Implementation disciplines. The aim of the forum is to better understand the range of legislative and operational barriers to the widespread adoption of fish screening technology. The letter should request a funding allocation in the order of \$80,000 to proceed with the forum as a matter of urgency. It is proposed that outcomes from the workshop be referred to the Minister for consideration, with potential subsequent development of a White Paper.

The 'Screens for Streams' project is about to commence and will be undertaken by DPI, Charles Sturt University and other industry partners. Council reiterated it is essential that onground trials commence as soon as possible to progress the research on this important issue. Input and buy-in from industry and water management partners is critical to ensure the success of this project.

Action item:

The Chair to write to the Minister to reiterate the importance of the 'Screens for Streams' project and need to ensure buy-in from other water partners during the further development of the initiative.

Action item:

DPI to provide an update on implementation of the 'Screens for Streams' project at the next meeting.

Action item: DPI to investigate the development of a decision making support tool/ framework that prescribes fisheries management actions to be applied as storage levels recede to critical levels and to report back at the next meeting

Action item: The Chair to write to Minister regarding the inclusion of 40 Golden Perch in Schedule 1C Indictable species and indictable quantities of the Fisheries Management Act 1994 as a deterrent to trafficking of the species on the inland.

Action item: DPI to facilitate Karl Mathers to update RFFTEC on the wide range of programs and initiatives aimed at achieving better water sharing and improved native fish outcomes in the Murray Darling Basin

9. Collection of Cockles at Lake Illawarra

DPI updated the Council on compliance reporting relating to a significant spike in the collection of cockles at Lake Illawarra, with some minor incidence of people exceeding the bag limit of 50. Social media appears to have contributed to the influx of harvesters in the area. There has been an increased DPI compliance presence around the Lake which is ongoing. DPI advised members that the current compliance rate with recreational fishing rules is 75%.

Stan Konstantaras raised an issue regarding a penalty infringement notice being issued to an adult assisting a child to collect cockles at Lake Illawarra and the adult not having paid the recreational fishing fee. Mr Konstantaras and Mr Samuels requested clarification regarding the current fee exemption for adults assisting a child and how they apply in the field.

Action item: DPI to provide background and history on the current exemption to the recreational fishing fee for adults assisting a child to Council at the next meeting.

10. Recreational Fishing Trust matters

New applications - project recommendations from RFSTEC and RFFTEC

DPI updated Council on the 2019/20 round of funding recommendations made by the Recreational Fishing Saltwater and Freshwater Trust Expenditure Committees (RFSTEC and RFFTEC) when they met on 30 and 31 January. A summary of the RFSTEC and RFFTEC recommendations was provided to Council in the agenda. The applications received covered a range of projects aimed at improving facilities, access and education for recreational fishing, and a variety of research projects to fill some of the information gaps related to recreational fishing issues.

RFNSW recognised the need for further research on black bream as outlined in the project titled: "Assess, develop and manage the recreational black bream fishery in southern NSW' and believes that further consideration is needed to identify how best to design and conduct the research.

Recommendation: Council endorsed the recommendations of RFSTEC and RFFTEC relating to new Trust applications that were supported and not supported, as outlined in Annex 1.

Recommendation: RFNSW recommended the application titled: "Assess, develop and manage the recreational black bream fishery in southern NSW' be resubmitted following reexamination of the stock structure of black bream in NSW (and the possible sharing of stocks with Victoria) using the latest population genetics methods.

11. Commercial fisher proposal for the Hastings River and additional RFHs correspondence

a) Commercial fisher proposal for the Hastings River

DPI advised the Council of a proposal from a mid-north coast commercial fisher regarding the Hastings River recreational fishing haven. RFNSW did not support any adjustments to existing havens as this would likely set a precedent for additional proposals. Any request should be considered as a significant proposal with statewide implications. There would also be a need for a statewide consultation strategy.

Action item: RFNSW identified Paul Lennon (and Dave Rae as a reserve) for the sub group formed by DPI to review the application in more detail.

b) Additional RFHs correspondence

Jo Starling informed the Council she had received a number of requests for additional recreational fishing havens at the following locations:

- 1. Nambucca River
- 2. Wallaga Lake
- 3. Lake Illawarra
- 4. Pambula River
- 5. Warrell Creek (request for lure and fly only waters)

Action item: Jo Starling to liaise with correspondents regarding current issues associated with creating additional havens.

12. Reports of dead fish at Jimmys Beach Port Stephens.

DPI updated Council on compliance reporting relating to the concerns raised about a social media video of dead fish at Jimmy's Beach Port Stephens. DPI advised that the issue was related largely to poor discard techniques for undersized sized fish by the commercial fishers involved.

Action item: DPI to include the issue of reducing and dealing with bycatch by the commercial fishing sector at the next joint CommFish meeting.

13. Correspondence

Additional letter from John Clarke to Chair regarding regional representation of RFNSW members

Action item: DPI to write to Mr Clarke reiterating the Chair's previous communication regional representation of RFNSW members.

14. Update on Southern Fish Trawl

DPI advised that the Minister is currently considering the issue of transitioning the NSW Southern Fish Trawl Fishery to the Commonwealth. This includes consideration of changes to the original transition proposal to accommodate issues raised by recreational fishing stakeholders. As no decision has yet been made, it is impossible to achieve the transition by 1 May 2019 (the start of the Commonwealth Southern and Eastern Scalefish and Shark Fishery quota season). Therefore, the next likely transition date, if approved, is for commencement on 1 May 2020.

DPI also advised that 166.9 tonnes is the total allowable catch allocation for tiger flathead for 2019/20 taken in the Ocean Trawl Fishery except the Southern Fish Trawl. Species shares were allocated to the Northern Fish Trawl, and Inshore and Offshore prawn shareholders.

15. Update on the use of Opera House traps in the inland

Council members were updated on the Opera House traps issue, including the Minster's response to previous RFNSW correspondence. The Minister advised DPI to develop a process to transition from the use of 'Opera House traps' to open top pyramid traps, which will have minimal impact on air breathing animals. The transition period will include a comprehensive promotion and education campaign for fishers, as well as the handing out of the new style traps to recreational fishers. RFNSW members noted the relevant Recreational Fishing Trust funding application to support the transition and education process.

Action item: DPI to keep Council updated on the progress of transitioning from the use of Opera House traps to open top pyramid traps.

16. Rockfishing safety

DPI advised that the local government areas (LGAs) for Northern Beaches Council and Richmond Valley Council had recently been gazetted. Sutherland Shire Council, Central Coast Council, Lake Macquarie City Council and Ballina Shire Council has also recently opted in to the Rock Fishing Safety Act and the gazettal process was being facilitated.

Negotiations with a range of other councils interested in opting-in to the Act continue. DPI has been developing a range of safe rock fishing communications initiatives including flyers, brochures, posters, signage, videos, social media posts, workshops and fishing media articles. DPI has engaged with a range of stakeholders to fine-tune these communication messages, including expert rock fishers, RFNSW members, local councils, members of the CALD fishing community, recreational fishing organisations, the tackle sector (including retailers), Police and DPI Fisheries compliance officers.

An advisory group consisting of expert anglers, the CALD community, the tackle sector, relevant government agencies and other relevant groups and organisations to assist DPI with managing and implementing the Rock Fishing Safety Act is also being developed.

17. Recreational fishing access

DPI briefed Council on the following issues at the meeting:

a) Risk assessment of recreational fishing in Sydney Water Supply Dams
DPI advised the risk assessment report has been finalised and is being provided to the
Minister for consideration.

b) Water Police patrols in Sydney Harbour

DPI reported that a number of public complaints had been received again this summer regarding irresponsible fishing on some ferry wharves. However, the issues are being addressed through Water Police patrols and ongoing advisory and education campaigns, which continue to be an effective strategy.

c) Pier 2/3 and Pier 8 in Sydney Harbour

DPI reported that more people are fishing on Pier 8 now that construction works on Pier 2/3 have reduced the fishing area on that Pier. Walsh Bay Precinct managers advise that there have been complaints about fisher-related litter, discarded fishing tackle, fish waste and excessive noise on Pier 8. In response, there has been an increased Police and Water Police presence, additional advisory activities, and targeted social media on fishing at Walsh Bay. More initiatives will be rolled out to address the above issues.

d) Spearfishing in the Eastern Suburbs of Sydney

DPI advised Council about correspondence seeking restrictions on spearfishing in Malabar Bay due to interactions with other groups such as swimmers, other divers and snorkelers. RFNSW advised that a non-regulatory, education approach is preferred to address conflict issues among fishers and other user groups.

Recommendation: RFNSW recommended development of a renewed targeted education campaign by a working group of relevant stakeholders, including key spearfishing organisations, DPI, spearfishing retailers, local Council and any other relevant stakeholders to address spearfishing issues in the Eastern Suburbs.

e) Ecohuts

DPI provided an update on the 14 ecohuts huts available across the state, excluding school and public holidays. DPI sought feedback from the Council on the option of DPI to obtain long-term leases or stand alone, DPI-managed huts to ensure the huts are available year round. Under the current system, the relevant National Parks and Wildlife Service huts are unavailable during school and public holidays.

18. General Business

a) Breakaway floats

An update on a social media campaign regarding littering and the responsible use of breakaway floats by fishers was provided by DPI. DPI presented draft social media tiles, brochures and posters to the Council. The Council supported the advisory information and requested that it be finalised so that it may be distributed throughout hot spot areas.

b) Update on progress towards actions recommended by RFNSW and CommFish during their joint meeting

DPI updated Council on the recommended action items from the joint session meeting on 22 November 2018.

Action item: The Chair to write to Peter Neville, Chair, RecFishing Research regarding engagement of a think tank to recommend additional, cost-effective methods to measure the recreational fisher catch. The letter should also be copied to Patrick Hone, Fisheries Research and Development Corporation.

Action item: DPI to circulate the Recreational Fishing trust funded project titled "Integrating recreational fishing information into harvest strategies for multi-sector fisheries in NSW" to members.

c) Lake Wallerawang access

Action item: Ray Tang to discuss access issues associated with the Wallerawang power station closure and potential changes to access arrangements in the future with the DPI Inland Access Officer.
